The Board of Morgan County Commissioners met on Tuesday, February 20, 2024 at 9:04 a.m. with Chairman Mark Arndt, Commissioner Jon Becker and Commissioner Gordon Westhoff in attendance. Chairman Arndt asked Tim Amen, Morgan County Assessor to lead the meeting in the Pledge of Allegiance.

At this time, the Board convened as the Morgan County Board of Social/Human Services. Chairman Arndt noted that Jacque Frenier, Morgan County Department of Human Services Director, and Accounting Manager Susan Nitzel were present.

#### Consideration of Approval –DHS Minutes dated January 23, 2024

Chairman Arndt presented for review and approval the Department of Human Services Minutes dated January 23, 2024. A motion was made by Commissioner Becker to approve the minutes as presented with Commissioner Westhoff seconding the motion. The motion carried 3-0.

#### **Consideration of Approval – DHS WARRANTS – December 2023**

Susan Nitzel, Accounting Manager presented to the Board for their review and approval the Department of Human Services Warrants for the month of December 2023. Ms. Nitzel summarized the operating warrants as being a total of \$261,092.22 for operating costs and direct deposits for payroll were \$224,413.25, which totaled \$485,505.47. Ms. Nitzel stated that a little more was spent from November to December and was mostly in operation costs.

Commissioner Westhoff made the motion to approve the warrants as presented for December 2023 in the amount of \$485,505.47 as presented and authorized the Chairman to sign with Commissioner Becker seconding the motion. Motion carried 3-0.

### Consideration of Approval – DHS CERTIFICATION OF PROVIDER AND VENDOR BENEFIT AUTHORIZATIONS – December 2023

Susan Nitzel, Accounting Manager presented to the Board for their review and approval the Department of Human Services Certification of Provider and Vendor Benefit Authorizations for December 2023. Ms. Nitzel summarized the Certification of Provider and Vendor Benefit Authorizations indicating the monthly total of \$911,915.43. Ms. Nitzel stated that costs went down from November mostly due to the LEAP program and the childcare program. She noted that from year to year, they are down \$1.9 million dollars of which \$1.5 million was the school lunch program which is funded at different times throughout the year.

Commissioner Becker made the motion to approve the Certification of Provider and Vendor Benefits as presented for December 2023 in the amount of \$911,915.43 as presented and authorized the Chairman to sign, with Commissioner Westhoff seconding the motion. Motion carried 3-0.

Ms. Frenier noted that requirements from before the Covid-19 pandemic were returning which is affecting eligibility of some people which has resulted in further interactions between affected citizens and staff.

There being no further business, the Board stood in recess at 9:11 a.m.
