GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

Consideration of Approval - Bid Tabulations - RFP 2020-1029-001 UPS Power Replacement System

Morgan County Communications Center Director, Danette Martin presented remotely to the Board for approval Bid Award 2020-1029-001 UPS Power Replacement System. Ms. Martin stated that this is also in connection with the maintenance department. Ms. Martin stated she received two bids from Critical Facilities Technology in the amount of \$70,917.00 which includes maintenance and from Daniel Newman dba Power Systems Engineering in the amount of \$46,707.00 which includes maintenance; however this bid did not meet the required bid specifications. Ms. Martin explained each bid in detail. Ms. Martin stated that the system is cloud based and they will be able to monitor it remotely.

At this time, Ms. Martin recommended to the Board to award the bid to Critical Facilities Technology in the amount of \$70,917.00 which includes maintenance.

Commissioner Becker made a motion to approve bid award RFP 2020-1029-001 UPS Power Replacement System to Critical Facilities Technology in the amount of \$70,917.00 which includes maintenance as outlined and recommended by Morgan County Communications Center Director, Danette Martin. Commissioner Zwetzig seconded the motion. At this time, the motion carried 3-0.

A RESOLUTION APPROVING STOP SIGNS INSTALLED AT THE INTERSECTION OF COUNTY ROAD 2 AND COUNTY ROAD O, MORGAN COUNTY, COLORADO.

WHEREAS, the Board of County Commissioners of Morgan County, Colorado, are vitally interested in Highway safety, for the benefit of the traveling public, and

WHEREAS, the Board determines that it is for the best interests of the general public and the recommendation of the Colorado State Patrol and Morgan County Sheriff, the follow Resolution be adopted:

NOW, THEREFORE, BE IT RESOLVED that due to traffic and safety, stop signs be placed at the following locations:

- 1. COUNTY ROAD 2 SOUTH OF COUNTY ROAD O, IN THE SOUTHEAST CORNER OF THE INTERSECTION STOPPING NORTHBOUND TRAFFIC ON COUNTY ROAD 2 AT COUNTY ROAD O
- 2. COUNTY ROAD O WEST OF COUNTY ROAD 2, IN THE SOUTHWEST CORNER OF THE INTERSECTION , STOPPING EASTBOUND TRAFFIC ON COUNTY ROAD 0 AT COUNTY ROAD 2
- 3. COUNTY ROAD O EAST OF COUNTY ROAD 2, IN THE NORTHEAST CORNER OF THE INTERSECTION, STOPPING WESTBOUND TRAFFIC ON COUNTY ROAD 0 AT COUNTY ROAD 2
- 4. RETAIN THE CURRENT STOP SIGN ON COUNTY ROAD 2 NORTH OF COUNTY ROAD O, IN THE NORTHWEST CORNER OF THE INTERSECTION, STOPPING SOUTHBOUND TRAFFIC ON COUNTY ROAD 2 AT COUNTY ROAD O

BE IT FURTHER RESOLVED that the proper law enforcement agencies be and hereby authorized and empowered to enforce compliance with this Resolution.

Morgan County Public Works Director, Bruce Bass, presented to the Board Resolution 2020 BCC 31 a Resolution Approving Stop Signs Installed at the Intersection of County Road 2 and County Road O, Morgan County, Colorado. Mr. Bass stated currently there are two yield signs and one stop sign. Mr. Bass stated that the resolution will make the intersection a four way stop as recommended by the Morgan County Sheriff and the Colorado State Patrol. Mr. Bass read the resolution aloud into the record. Chairman Arndt stated that this matter has been posted for 10 days and there has not been any public comment as of today.

Commissioner Zwetzig made a motion to approve Resolution 2020 BCC 31 a Resolution Approving Stop Signs Installed at the Intersection of County Road 2 and County Road O, Morgan County, Colorado as presented by Morgan County Public Works Director, Bruce Bass with Commissioner Becker seconding the motion. COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS

Commissioners reviewed the calendar dated November 6, 2020, 2020 through November 17, 2020 with no changes.

Morgan County Public Works Director, Bruce Bass presented the road report ending November 6, 2020 reading the report into the minutes.

Laura Teague, Northeast Colorado Health Department board member stated that there will be a meeting next week to go over the COVID-19 data and implications from the current spike.

Commissioner Becker stated that small businesses will likely not weather the storm through a second closure if that is to occur.

Commissioner Zwetzig and Commissioner Becker both explained that the change in dialing back a phase due to the COVID-19 numbers came from Governor and from CDPHE, not from the County Commissioners.

Morgan County Tourism Marketing Manager, Kristen Clifford-Basil gave an update on the CARES grant stating they have distributed out \$348,000 in grant funds to local businesses as of Friday. Ms. Clifford-Bail stated that the deadline has been extended to November 15, 2020. She explained that the Town of Wiggins has opened up a grant program as well. Ms. Clifford –Basil stated that tourism revenue is down fifty two percent from last year. She stated that future meetings will be going virtual given the change of dial related to COVID-19.

Chairman Arndt asked if there was any further business to bring before the Board, and upon hearing none, the meeting was adjourned at 9:32 a.m.
