RESOLUTION TO ADOPT BUDGET

A RESOLUTION SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND ADOPTING A BUDGET FOR MORGAN COUNTY, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2021, AND ENDING THE LAST DAY OF DECEMBER 2021.

WHEREAS, the Board of County Commissioners of Morgan County has appointed Budget Officer, Michelle Covelli, to prepare and submit the proposed budget to said governing body at the proper time, and;

WHEREAS, Budget Officer, Michelle Covelli, has submitted the proposed budget to this governing body on October 15, 2020, for its consideration, and;

WHEREAS, upon due and proper notice, published and posted in accordance with the law, said proposed budget was open for inspection by the public at a designated place, a public hearing was held on November 17, 2020, and interested taxpayers were given the opportunity to file or register any objection to said budget, and;

WHEREAS, whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law.

NOW, THEREFORE, BE IT RESOLVLED BY THE BOARD OF COUNTY COMMISSIONERS of the County of Morgan, Colorado:

Morgan County Finance Director, Michelle Covelli presented to the Board for approval, a Resolution 2019 BCC 37, a Resolution Summarizing Expenditures And Revenues For Each Fund Adopting A Budget For Morgan County, Colorado, For The Calendar Year Beginning On The First Day Of January 2021, And Ending On The Last Day Of December 2021. Ms. Covelli explained the 2021 Budget Highlights:

The 2021 budget total is \$47,486,749.

The budget is balanced. Total property tax revenue is \$18,612,493. Total revenue from other sources is \$20,883,513 and total from fund balance is \$7,990,743.

General Fund budget is \$18,034,755.

Road and Bridge Fund budget is \$8,688,217.

Social Services 2021 budget is \$5,818,789.

911 Emergency Telephone Fund budget is \$1,051,500.

Lodging and Tourism Fund budget is \$231,200.

Conservation Trust Fund budget is \$260,000.

Confiscation Seizure Fund budget is \$4,000.

Jail Capital Improvement Fund budget is \$2,150,000.

Ambulance Service Budget is \$1,777,629.

Solid Waste Management Fund budget is \$2,173,611.

Central Services Fund Budget is \$7,297,048.

Ms. Covelli stated the 2021 budget does reflect an increase from the 2020 budget, 11 percent increase, due to mainly capital improvement projects with Ms. Covelli providing an explanation of those projects and also indicated the grand total for capital outlay projects as being \$11,831,213. She stated there is a project planned for energy efficiency at the Justice Center where it is hopeful to obtain grant funding, and the other projects are those for the central services fund, and road and bridge fund. Discussion also followed regarding the solid waste management cell construction project and this project is scheduled to commence in 2021.

Ms. Covelli stated the budget also reflects monies for salary increases at a 3 percent cost of living increase as well as an additional overall salary increase of 3 percent, stating the County is attempting to keep up with inflation and maintain cost of living increases and allow the department managers to evaluate their employees and grant merit increases as they see fit.

RESOLUTION TO SET MILL LEVIES

A RESOLUTION LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 2020, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE COUNTY OF MORGAN, COLORADO, FOR THE 2021 BUDGET YEAR.

WHEREAS, the Board of County Commissioners of the County of Morgan has adopted the annual budget in accordance with the Local Government Budget Law, on December 10, 2020, and;

WHEREAS, the amount of money necessary to balance the budget for the general operating purposes General Fund is \$12.517,819 and;

WHEREAS, the amount of money necessary to balance the budget for Road and Bridge Fund is \$4,811,585, and;

WHEREAS, the amount of money necessary to balance the budget for Social Services Fund is \$1,283,089, and;

WHEREAS, the 2020 valuation for assessment for the County of Morgan as certified by the County Assessor is \$641,544,610

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF MORGAN, COLORADO:

Section 1. That for the purpose of meeting all general operating and other expenses of General Fund of the County of Morgan during the 2021 budget year, there is hereby levied a tax of 19.512 mills upon each dollar of the total valuation for assessment of all taxable property within the County for the year 2020.

Section 2. That for the purpose of meeting all operating and other expenses of the Road and Bridge Fund of the County of Morgan during the 2021 budget year, there is hereby levied a tax of 7.500 mills upon each dollar of the total valuation for assessment of all taxable property within the County for the year 2020.

Section 3. That for the purpose of meeting all operating and other expenses of the Social Services Fund of the County of Morgan during the 2021 budget year, there is hereby levied a tax of 2.000 mills upon each dollar of the total valuation for assessment of all taxable property within the County for the year 2020.

Morgan County Finance Director, Michelle Covelli presented to the Board for approval, a Resolution 2020 BCC 38, a Resolution Levying General Property Taxes For The Year 2020, To Help Defray The Costs Of Government For The County Of Morgan, Colorado, For The 2021 Budget Year. Ms. Covelli summarized each figure as the resolution outlined noting that the mill levy will be certified at a total of 29.012 for 2021, which will include an abatement mill levy of .064 and explained this is done annually according to the assessed values as certified by the Morgan County Assessor, with the abatement total being \$41,059.00. Ms. Covelli provided a summary of the County's assessed value as being \$641,544,610. Ms. Covelli then read aloud the mill levies that will be necessary to certify in order to cover the County's 2021 budgeted expenditures.

Morgan County Finance Director, Michelle Covelli presented to the Board for approval, a Resolution 2020 BCC 40 a Resolution Adopting A Supplemental Budget For The General Fund For Calendar Year 2020. necessary to work through the health crisis, this was necessary given this is new expenditures, and new revenue collected by the County, the need was there for this supplemental budget.

Commissioner Becker made a motion to approve Resolution 2020 BCC 40, a Resolution Adopting A Supplemental Budget For The General Fund For Calendar Year 2020, as presented by Morgan County Finance Director, Michelle Covelli, with Commissioner Zwetzig seconding the motion. Commissioner Zwetzig asked to note that the finance department and all departments have done a tremendous job and expressed his appreciation during this challenging year. At this time, the motion carried 3-0.
