Consideration of Approval – RESOLUTION – 2017 BCC 16 – A Resolution approving a Use by Special Review for a Communication Tower located in the Southwest $\frac{1}{4}$ of Section 36, Township 2 North, Range 56 West of the 6^{th} P.M., to be known as 6159 Highway 71, Brush, Colorado 80723, Morgan County

MORGAN COUNTY, COLORADO BOARD OF COUNTY COMMISSIONERS

RESOLUTION NO. 2017 BCC 16

A Resolution Approving a Use by Special Review for a Communication Tower located in the Southwest ¼ of Section 36, Township 2 North, Range 56 West of the 6th P.M., to be known as 6159 Highway 71, Brush, Colorado 80723, Morgan County

WHEREAS, NE Colorado Cellular Inc. d/b/a Viaero Wireless ("Applicant") has applied for a Special Use permit to place a free standing "CMRS" Commercial Mobile Radio Service facility which would consist of a 195 ft. tall guyed mono-pole type antenna support structure/tower located in the SW1/4 of Section 36, Township 2 North, Range 56 West of the 6th P.M., to be known as 6159 Highway 71, Brush, Colorado 80723, Morgan County, Colorado ("Property");

WHEREAS, the Property is located within the "A" Agriculture Production zone district;

WHEREAS, the Morgan County Planning Commission recommended approval of the application;

WHEREAS, on May 2, 2017, the Board of County Commissioners of Morgan County, Colorado ("BoCC") held a public hearing pursuant to the Morgan County Zoning Regulations;

WHEREAS, notice of the public hearing before the Board of County Commissioners ("BoCC") was properly published and the subject property was properly posted;

WHEREAS, during the public hearing, the BoCC received testimony from the Applicant and the Morgan County Planning Staff, and

WHEREAS, public comment was not received on the application during the public hearing.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MORGAN COUNTY, COLORADO:

- 1. The BOCC, having reviewed the application, all information provided, testimony heard, and the criteria for approval of a Use by Special Review as set forth in County's Zoning Regulations, finds that:
 - a. The use and its location proposed are in conformance with the Morgan County Comprehensive Plan.
 - b. The application documents are complete and present a clear picture of how the use is to be arranged on the site.
 - c. All on and off-site impacts have been satisfactorily mitigated.
 - d. The special use proposed has been made compatible with surrounding uses and is adequately buffered from any incompatible uses by distance and topography.
 - e. The special use poses no or minimal risk to the public health, safety and welfare.
 - f. The special use proposed is not to be developed on a nonconforming parcel of land.
 - g. The tower height of 195 feet is approved pursuant to Sec. 4-715(B) of the County's Zoning Regulations and no variance from the BOA is required.
 - h. The Applicant has adequately documented a public need for the project in the form of increased improved coverage for wireless device users and economic development. The Applicant has submitted all pertinent technical information, has demonstrated that they have adequate financial resources to implement the project, and has paid all fees and review costs.
- 2. The BoCC hereby approves the Use by Special Review subject to the following conditions:
 - a. The Applicant is required furnish any purchaser or other successor in interest to the permitted property with a copy of the Morgan County Right to Farm Policy/Notice as adopted by Resolution 96 BCC 41 on July 23, 1996, and amended by Resolution 2008 BCC 34 on September 2, 2008, and the Receipt and Statement of Understanding of said policy. The Policy and Receipt shall be recorded as addenda to any deeds conveying the permitted property from the Applicant to any purchaser or other successors.
 - b. Any past, existing, or future drainage problems on this property are the responsibility of the landowner and not that of Morgan County.

- c. All federal and state approvals for the tower shall be forwarded to the Morgan County Planning Department.
- d. Morgan County shall have the option to co-locate emergency broadcast equipment at no cost to the applicant. In the event that Morgan County co-locates emergency broadcast equipment, the County shall provide the applicant with specifications of the equipment and engineering for tower loading.
- e. The Board of County Commissioners retains continuing jurisdiction on this permit to address future possible problems with the site and to insure compliance with the conditions of this permit and the Morgan County Zoning regulations. The County also retains jurisdiction and the right and authority of County personnel to inspect the site at any reasonable time.
- f. If the facility is not used for a period of 12 consecutive months, it shall be removed within 90 days of the end of the 12 month period. In the event the owner fails to remove the CMRS facility within the time limit specified above, the County is hereby authorized to remove or cause the removal of the CMRS facility without any liability for trespass, and all costs incurred by the County, including an administrative cost equal to twenty-five percent (25%) of all direct costs, shall be charged as a lien against such real property which was occupied by the CMRS facility and the owners thereof.
- g. Co-location with other providers will be granted by NE Colorado Cellular if and when possible as required by the zoning regulations.
- h. Within five days after the construction reaches its greatest height notify the Federal Aviation Administration as required by Form 7460-2 Supplemental Notice For Advance Notice of Actual Construction or Alteration.
- i. Applicant shall remain in compliance with all other conditions by the FAA per the Determination of No Hazard dated February 28, 2017.
- j. The Applicant is responsible for complying with all the foregoing requirements, conditions and design standards. Noncompliance with any of the foregoing requirements, conditions or design standards may be reason for revocation of this permit by the Board of County Commissioners after notice to the applicant or its successors in interest and public hearing.

Morgan County Planning Director and Floodplain Administrator Pam Cherry presented to the Board for approval, Resolution 2017 BCC 16, a Resolution approving a Use by Special Review for a Communication Tower located in the Southwest ¼ of Section 36, Township 2 North, Range 56 West of the 6th P.M., to be known as 6159 Highway 71, Brush, Colorado 80723, Morgan County. Ms Cherry stated this is the draft resolution that had been presented at the hearing held two weeks ago and is asking for the board to approve.

Commissioner Teague made a motion to approve Resolution 2017 BCC 16 a Resolution approving a Use by Special Review for a Communication Tower located in the Southwest ¼ of Section 36, Township 2 North, Range 56 West of the 6th P.M., to be known as 6159 Highway 71, Brush, Colorado 80723, Morgan County, as outlined Morgan County Planning Director and Floodplain Administrator Pam Cherry. Commissioner Arndt seconded the motion and motion carried 3-0.

$Consideration \ of \ Approval-RIGHT \ OF \ WAY-2017 \ PMT \ 15-Wiggins \ Telephone \ Association$

Morgan County Road Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2017 PMT 15, with Wiggins Telephone Association. Mr. Goodman stated this right of way permit is to trench south right of way and across County Road U starting at a point 2909 feet west of the intersection of County Road U and County Road 3 at an existing vault, trench east a distance of 250 feet parallel to County Road U then continuing

north across County Road U to the north right of way of County Road U for the purpose of installing new fiber service at 2501 County Road U, Wiggins, CO. He stated the fees are attached in the amount of \$175.00 and the location has been inspected.

Commissioner Arndt made a motion to approve Right of Way Permit 2017 PMT 15 with Wiggins Telephone Association as outlined in the narrative of the permit and presented by Morgan County Road Supervisor John Goodman and authorized the Chair to sign. Commissioner Teague seconded the motion and motion carried 3-0.

Consideration of Approval - RIGHT OF WAY - 2017 PMT 16 - City of Fort Morgan

Morgan County Road Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2017 PMT 16, with City of Fort Morgan. Mr. Goodman stated this right of way permit is to bore through north right of way of County Road S starting at a County Road 17 boring on the north side of County Road S for 2500 feet ending at Highway 144 right of way for the purpose of installing new fiber backbone. He stated the fees are attached in the amount of \$300.00 and the location has been inspected.

Commissioner Teague made a motion to approve Right of Way Permit 2017 PMT 16 with City of Fort Morgan as outlined in the narrative of the permit and presented by Morgan County Road Supervisor John Goodman and authorized the Chair to sign. Commissioner Arndt seconded the motion and motion carried 3-0.

Consideration of Approval – INTERGOVERNMENTAL AGREEMENT – 2017 IGA 04 Kit Carson Human Services

Commissioner Teague presented to the Board for approval, an Intergovernmental Agreement, 2017 IGA 04 with Kit Carson Human Services. Commissioner Teague asked this IGA be considered explaining this IGA will cover Morgan County staff to provide advice to the Kit Carson County Child Welfare Department due to a shortage in staff. She outlined the required fees that will be charged, for a total of \$2,750 per month.

Commissioner Arndt made a motion to approve 2017 IGA 04 with Kit Carson Human Services as presented by Commissioner Teague, noting the Director has the right to terminate at any time with Commissioner Teague seconding the motion. At this time, the motion carried 3-0.

Chairman Zwetzig noted a letter of thanks has been received from the Kit Carson County Board of Commissioners for this assistance.

COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS

Commissioners reviewed the calendar dated May 12, 2017 through May 23, 2017 with changes.

Commissioner Teague made note of a meeting scheduled at 6:00 p.m. at the Mark Arndt Event Center, FEMA/Beaver Creek Informational Meeting with Pam Cherry explaining the purpose of the meeting as being to discuss the process of what will happen for the adoption of the floodplain maps, primarily geared towards Morgan County floodplain areas, rather than the City of Brush, with the majority of the floodplain being in the City of Brush. She understands that the City of Brush will have staff present in case there are specific questions regarding the City of Brush areas.

Commissioner Arndt made note of the citizen meeting which is scheduled for May 23, 2017 at 6:00 p.m. in the Assembly Room, located at 231 Ensign Street, Fort Morgan where Western Sugar representatives will be present for citizens to have the opportunity to speak with management regarding any concerns about the facility.
