The Board of Morgan County Commissioners met Tuesday, August 15, 2017 at 9:07 a.m. with Chairman James Zwetzig and Commissioner Mark Arndt in attendance with Commissioner Laura Teague absent. Chairman James Zwetzig called the meeting to order and asked Morgan County Human Resources Director to lead the meeting in the Pledge of Allegiance.

#### GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

#### Consideration of Request - I-76 Fort Morgan to Brush, CO - Colorado Department of Transportation

Donald Mitchell Right of Way Agent for CDOT, 1601 West 10<sup>th</sup> Street, Greeley, CO presented to the Board a consideration request in regards to I-76 Fort Morgan to Brush, CO. Mr. Mitchell stated what he has presented to the Board is an offer to purchase property indicating this is a corner of property that they would like to acquire to accommodate and facilitate the off-ramp coming off of Interstate 76 at Highway 144 (Log Lane).

Chairman Zwetzig asked if they had a map to reflect this location with Rich Barker, CDOT, same address, stating they are fortunate to have the two property engineers, one for I-76 and the other for Highway 144, and indicated the display that indicates the parcel, the location and the need for the parcel. A map was then demonstrated that indicated that they are changing it from a cloverleaf to a diamond indicating this is a safety issue that meets the federal guidelines. He stated the parcel they wish to purchase is for the eastbound off ramp, and will also be making an offer to WAPA in the same area for the same reason. He stated they are constrained and the area that parallels the Fort Morgan canal, indicating they are constrained by that such as they have had to design around that to facilitate the federal guideline. He stated they could provide an aerial mapping if that would help clarify further.

Commissioner Arndt asked about the drainage that goes under I-76 and comes out, where the location of that would be on the map being displayed. Mr. John Goodman, Morgan County Road Supervisor, pointed out on the displayed map indicating the drainage pipe location within the vicinity of what was being discussed explaining that this drainage pipe allows for drainage for the southern area of this locale and indicated the exact locations of where it drains and dumps into. He stated there is a culvert that runs under I-76 explaining on the east side (naming the Schocke residence) straight east of there; it should then drain to the river from there. He offered to meet Morgan County personnel to show them where this infrastructure is located.

Mr. Taher Zarinkhel, Project Manager/Project Engineer, 10601 W. 10<sup>th</sup> Street, Greeley, Colorado stated this project was designed in 1976 and indicated the several changes that have occurred, stating they are now working off of the regulations set forth in 2011, stating they have had many issues with the terrain and the soil itself. He stated the soil in this area is very sandy, does not absorb the water and drainage is an issue. Taking the measure of the drainage issues they have on State Highway 144 and State Highway 52, they have considered multiple options to mitigate the drainage issues. He pointed out the plan to mitigate the issues on State Highway 144, and I-76 and changed the design in actually widening the ramps whereas they will not have the tremendous run-off issue. They have also implemented new storm water systems and in the area, they have new storm drains placed on I-76 itself. He stated the bridge itself on State Highway 144 is on a curve and explained the guardrails, and infrastructure they are placing to make this a safer area.

Mr. Mitchell also stated they will make note of the information shared by Mr. Goodman given the County's infrastructure being discussed today. Mr. Mitchell further explained their plan to make the slope 6-1 and the gutters that will catch the water off of I-76 into a nice inlet and then discharge it nicely so it does not create drainage problems. AECOM is the design team who has assisted with the design.

Chairman Zwetzig stated the County is bringing in additional water given the project that was completed in 1993 on Morgan County Road Q and wanted to ensure they are taking this into consideration as well, with Mr. Mitchell stating they will be sure to look into this and take this into consideration.

Commissioner Arndt stated it would be helpful to have this location staked out and Mr. Goodman stated he agreed it would be good for CDOT to see the locale in question and understand the drainage plan the County has in place.

Mr. Zarinkhel stated they do work closely with Dawn Walker who is the Brush area supervisor for CDOT in regards to the area.

Commissioner Arndt asked when the project start date is set for, with Tier 1 project in the State of Colorado, stating that this is a priority project on the list and given the drainage issues that exist, this has been a project that they are working on obtaining the funding and hoping to get the project moving forward as soon as they can.

He stated they are just waiting on funding and feel optimistic to get the funding for what he considered Phase V, as this will benefit the people of Fort Morgan and those driving on I-76, and stated that unfortunately they cannot provide an exact date, but once they obtain the funding it will commence immediately. He assured the Board that I-76 is on their high priority list.

Recent sales, vacant land sales in the area, stating there are different types of zoning, and they look at all this data. He stated that because it is vacant land they are purchasing that is what they look at on the purchase side. He stated this entire parcel is zoned commercial; just the southeast corner is developed with the County maintenance site. He stated the area they are acquiring is non-developed and could not be developed given the setbacks. He summarized what they are looking at, based on size of acreage, trying to keep it apples to apples as much as possible.

Commissioner Arndt stated he would like to table this matter to allow CDOT to stake out the site, the location in question, to be sure they can see the County's location including the fuel site, and is in support of the project given the safety aspects, but would like to safeguard the County's investments as well.

Chairman Zwetzig asked if this is for the purchase with Mr. Mitchell stating it is for the purchase of access of right of way, with Mr. Barker stating this being an offer of fair market value, and Mr. Mitchell stated since they have not acquired the property yet, they will need permission for their surveyors to access the property. Chairman Zwetzig stated the Board is not against selling the property but the Board wants to ensure that the County's infrastructure is protected. Mr. Barker stated that the Board is correct and they would be happy to accommodate the County's request. This would be a fee acquisition with Chairman Zwetzig asking Pam Cherry, Morgan County Planning Director/Floodplain Administrator, if there is anything in regulations that would need to be done with Ms. Cherry stating she would have to check regulations but off hand does not believe so.

Mr. Zarinkhel stated that the safety aspect of the area is what is major things they are having to look at and has been one of the challenges to this project and in the design of the project they have taken this into consideration.

Commissioner Arndt made a motion to allow CDOT to enter the property for survey access and further stated his motion would include authorize the CDOT permission to enter the property, location being I-76, Phase 5, 17303 County Road S, Fort Morgan, CO and to work with the public works and road supervisor to make sure that all the County's concerns are met, and authorized the Chair to sign and Chairman Zwetzig seconded the motion.

Mr. Barker summarized Phase IV, indicating they are putting in place these projects and connecting completion of all the phases as proposed. Chairman Zwetzig spoke about Beaver Creek and how Highway 71 and I-76 affect the floodplain. Mr. Zarinkhel stated that in working on SH 52, they worked with the floodplain issues, and indicated they are not raising the roadway and are mitigating the new storm system to mitigate the water drainage issues for the citizens of Fort Morgan. Chairman Zwetzig further commented about the area in Brush, as having some issues that also need mitigated. Pam Cherry stated the letter of final determination on the preliminary floodplain maps are due next week, and there is quite a bit of work that needs to be done at the Highway 71 and I-76 area. Mr. Zarinkhel further spoke about his past workings with State Highway 52 and how it provided him a better understanding about the soil in this area and the floodplain area and now feels they have better data to work through this issue to best mitigate the drainage issues at hand. Commissioner Arndt asked about the Wildcat Draw, that it would help the County if they had any floodplain studies on the project for a project the County has on County Road Y, if they could provide that information, it would be helpful and save the County some money on the County Road Y project. Mr. Barker agreed with Commissioner Arndt. At this time, the motion passed 2-0.

#### Consideration of Request – Hwy 144 flooding – Colorado Department of Transportation

Rich Barker Acquisition Agent for CDOT presented to the Board a consideration request in regards to Hwy 144 flooding. Mr. Barker provided a display map for the County to review and provided a complete packet of information to the Board with information. He stated that studies have been completed indicating the property owner that these studies were completed for. He stated they looked at an area indicated as the Orphan Wells facility on John Yocum's property on an easement and looked at accommodating that with aligning the pipe but there being restrictions of their recorded easement led them to work towards the east of the Orphan Wells facility and then lines in with the Orchard bridge. He spoke about the flood which changed the direction of the river and stated with this new alignment, they needed to purchase about 26 acres from Mr. Yocum, and what he would like is a proposed vacation of the old right of way that Morgan County had acquired in 1907, and in 1913 the State took it over as a state highway.

He also provided a display which indicates the area labeled as EX-2, is the portion of the old right of way they would like to ask that the County vacate their easement. He stated what they would do from CDOT, they would get their engineer report back to Mr. Yocum as far as any easements and right of way access. Mr. Yocum should get the full easement, as per Mr. Barker and he showed this area on the map. He stated this was all purchased from the Yocum ownership and is included in the deed to the property. He stated they will facilitate a property just west of the highway, basically an augmentation program recently as last year, and they own the parcel he pointed to, southwest quarter of section 18, as well as a portion of the area adjacent. The area above is a different ownership and he indicated that these owners would have access indicating County Road V as providing access and CDOT will

not be giving up the area to the south. The owner on the north will have access that CDOT will put back in as part of the construction of the project.

Currently there is no permit or access established into the west side of the current alignment. Chairman Zwetzig asked about the request today as being for a vacation of the right of way, with Mr. Barker stating yes and Chairman Zwetzig stated there is a proper process the County will have to take in doing this so no action could be taken today until this process is taken so landowners are notified.

Mr. Barker stated there is access, the Bijou Creek Ranch LLC property, as per Mr. Barker. The other owner is the Central Colorado Water Conservancy Groundwater Management property who owns parcels in the locale as he pointed out on the display.

Commissioner Arndt stated the Board would need to proceed properly and schedule this matter for a public hearing with Mr. Barker stating he understands and believes that today is being used as an informational meeting.

Mr. Craig Schumacher, Colorado Department of Transportation, 10601 W. 10<sup>th</sup> Street, Greeley, CO summarized how CDOT will be constructing this project in how the flow of water will occur and pointed out the areas on the display stating given a portion of the road is in the floodplain, stating there is larger rock, with smaller rock and smaller rock, and explained how they construct the area to proceed with the project at hand. Chairman Zwetzig stated their design would allow for the pavement never getting washed away, allowing the floodwater to go where it was already going and allow the road to be there when the flooding is over. Additional costs to build a road in this manner is "pretty expensive" as per Mr. Schumacher and stated to get the rock hauled, will probably come from Idaho Springs, which will make it costly and believes it is a good project. 1.6 miles includes the culvert which will have the main walls redone as well for a cost of approximately 11 million dollars.

Mr. Barker stated the plan is to mill the asphalt off of the existing and would not cut it down but use it as a buffer in case we would get another 100 year flood event, it would help in protecting it as well.

Chairman Zwetzig stated in regards to this matter, the Board will send this information and request to the County Attorney to further process in following the County's policy.

Discussion followed in regards to historical and environmental research that was recently done, with Mr. Barker stating he could provide the information to the County Attorney and they had obtained the approval to move this roadway over as it has been moved.

Commissioner Arndt asked Mr. Barker to work with the Administrative Assistant to notify the landowners of the project and it was stated the project is hopeful to start spring of 2018. Mr. Barker stated that timing of the project depends on funding and indicated there is a time limitation. It was stated that the road would not be closed during the project construction, only for a period of about 7 days, so the inconvenience to traffic will be minimal as per CDOT representation. Ms. Cherry stated CDOT will need a floodplain development permit for this project.

Commissioner Arndt asked if there is not a legal process to ask the County to transfer its rights to the Colorado Department of Transportation with Mr. Barker stating they have this same question in other counties, stating there was no mechanism and has not seen any assignments of easements from County to State. He agreed it would have made things simpler, but he has not seen any kind of process that would allow this.

  - (a) The application documents are complete and present a clear picture of how uses are to be arranged on the site.
  - (b) The site plan conforms to the design standard of these Regulations.
  - (c) There are no off-site impacts imposed by the conditional use that have not been addressed with the City of Fort Morgan approved drainage plan. Additional infrastructure (utilities and roads) or upgrades are not required by the County or Special Districts.
  - (d) The use proposed is compatible with the surrounding uses and adequately buffered as necessary.
- 2. The Board of County Commissioners hereby conditionally approves the Conditional Use subject to the condition:
  - (a) The site will be graded and retention/detention constructed in compliance with the City of Fort Morgan approved drainage plans.

#### **RESOLUTION NO. 2017 BCC 29**

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MORGAN COUNTY, COLORADO, ADOPTING A FAIR HOUSING POLICY AND MAKING KNOWN ITS COMMITMENT TO THE PRINCIPLE OF FAIR HOUSING, AND DESCRIBING ACTIONS IT SHALL UNDERTAKE TO AFFIRMATIVELY FURTHER FAIR HOUSING

WHEREAS, the Housing and Community Development Act of 1974, as amended, requires that all applicants for Community Development Block Grant funds certify that they will affirmatively further fair housing;

WHEREAS, the Civil Rights Act of 1968 (commonly known as the Federal Fair Housing Act) and the Fair Housing Amendments Act of 1988, declare a national policy to prohibit discrimination in the sale, rental, leasing and financing of housing or land to be used for the construction of housing or in the provision of brokerage services, on the basis of race, color, religion, sex, disability, familial status or national origin;

WHEREAS, the Colorado Anti-Discrimination Act, specifically C.R.S. § 24-34-501 *et seq.*, as may be amended, prohibits discrimination in housing on the basis of disability, race, creed, color, sex, sexual orientation, marital status, familial status, religion, national origin, or ancestry;

WHEREAS, fairness is the foundation of the American system and reflects traditional American values; and

WHEREAS, discriminatory housing practices undermine the strength and vitality of America and its people.

NOW, THEREFORE, be it resolved by the Morgan County Board of County Commissioners, Colorado, as follows:

- 1. Morgan County will not discriminate in the sale, rental, leasing or financing of housing, because of disability, race, creed, color, sex, sexual orientation, marital status, familial status, religion, national origin, or ancestry.
- 2. Morgan County will assist all persons who feel they have been discriminated against, because of disability, race, creed, color, sex, sexual orientation, marital status, familial status, religion, national origin, or ancestry to seek equity under federal and state laws by providing information to said person on how to file a complaint with the Colorado Division of Civil Rights.
- 3. Morgan County will at a minimum post this policy or the Fair Housing poster or other posters, flyers or other information which will bring to the attention of owners of real estate, developers and builders their respective responsibilities and rights under the Federal Fair Housing Act and the Colorado Anti-Discrimination Act.

Morgan County Finance Director Michelle Covelli presented to the Board for approval, Resolution 2017 BCC 29, a Resolution of the Board of County Commissioners of Morgan County, Colorado, adopting a Fair Housing Policy

and making known its commitment to the principle of fair housing, and describing actions it shall undertake to affirmatively further fair housing. Ms. Covelli stated this resolution basically adopts a fair housing policy, which states the County shall not discriminate against anyone in regards to any transactions. The County receives Community Block Development grant funds and under those funding requirements, the County must adopt and comply with this rule.

Commissioner Arndt made a motion to approve Resolution 2017 BCC 29, A Resolution of the Board of County Commissioners of Morgan County, Colorado, adopting a Fair Housing Policy and making known its commitment to the principle of fair housing, and describing actions it shall undertake to affirmatively further fair housing, as outlined by Morgan County Finance Director Michelle Covelli noting Commissioner Teague is absent today. Chairman Zwetzig seconded the motion and at this time, the motion carried 2-0.

#### Consideration of Approval - RIGHT OF WAY - 2017 PMT 22 - Xcel Energy

Morgan County Roads Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2017 PMT 22, with Xcel Energy. Mr. Goodman stated this right of way permit is to dig parallel to County Road 16 in the east right of way, starting approximately 613 feet south of the intersection of County Road O and parallel to County Road 16 in the east right of way and ending approximately 913 feet south of the intersection of County Road O and parallel to County Road 16, for the purpose of installing guardrail for protecting Xcel Gas Facility LB-16. Chairman Zwetzig asked about the guardrails as being placed in different locations and how are they designed to be in a right of way as they look as they could be an obstacle if a vehicle should run into them. Mr. Goodman stated to the best of his knowledge, they would place a breakaway designed guardrail if it should be hit by a vehicle to provide safety. He indicated the placement of the guardrail as it is actually in the right of way off the roadway. Chairman Zwetzig seconded the motion and motion carried 2-0.

#### Consideration of Approval - RIGHT OF WAY - 2017 PMT 23 - Xcel Energy

Morgan County Roads Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2017 PMT 23, with Xcel Energy. Mr. Goodman stated this right of way permit is to dig parallel to County Road I in the north right of way, starting approximately 6 feet east of the intersection of County Road 4 and parallel to County Road I in the north right of way and ending approximately 212 feet east of the intersection of County Road 4 and parallel to County Road I, for the purpose of installing guardrail for protecting Xcel Gas Facility LB-18-M. Chairman Zwetzig made note the packet did include an actual picture of the location.

Commissioner Arndt made a motion to approve Right of Way Permit 2017 PMT 23 with Xcel Energy as outlined in the narrative of the permit noting the fees are attached as presented by Morgan County Roads Supervisor John Goodman and authorized the Chair to sign. Chairman Zwetzig seconded the motion and motion carried 2-0.

#### Consideration of Approval - RIGHT OF WAY - 2017 PMT 24 - Xcel Energy

Morgan County Roads Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2017 PMT 24, with Xcel Energy. Mr. Goodman stated this right of way permit is to dig parallel to County Road I in the north right of way, starting approximately 1546 feet west of the intersection of County Road 7 and parallel to County Road I in the north right of way and ending approximately 1809 feet west of the intersection of County Road 7 and parallel to County Road I, for the purpose of installing guardrail for protecting Xcel Gas Facility LB-10-M.

Commissioner Arndt made a motion to approve Right of Way Permit 2017 PMT 24 with Xcel Energy as outlined in the narrative of the permit noting the fees are attached as presented by Morgan County Roads Supervisor John Goodman and authorized the Chair to sign. Chairman Zwetzig seconded the motion and motion carried 2-0.

Chairman Zwetzig seconded the motion and motion carried 2-0.

#### Consideration of Approval - RIGHT OF WAY - 2017 PMT 26 - Morgan County Quality Water District

Morgan County Roads Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2017 PMT 26, with Morgan County Quality Water District. Mr. Goodman stated this right of way permit is to trench in the east right of way of County Road 5, starting at a point 3,200 feet north of County Road E on the east side of County Road 5 at the existing 4" main located in the borrow ditch on the east side of County Road 5, ending east to the east line of County Road 5 right of way, for the purpose of installing new water service. He stated the fees are

attached in the amount of \$50.00 and the location has been inspected.

Chairman Zwetzig asked Mr. Goodman about the criteria that is used for the right of way where Morgan County Quality Water places their water meters with Mr. Goodman stating that 99.9 percent of the time, Morgan County Quality Water District places their meters on the property owner's private property, not on the County's right of way.

Commissioner Arndt made a motion to approve Right of Way Permit 2017 PMT 26 with Morgan County Water District as outlined in the narrative of the permit noting the fees are attached as presented by Morgan County Roads Supervisor John Goodman and authorized the Chair to sign. Chairman Zwetzig seconded the motion and motion carried 2-0.

#### Consideration of Approval - CONTRACT - 2017 CNT 166 - Centennial Mental Health Center, Inc.

Morgan County Department of Human Services Director Jacque Frenier presented to the Board Contract 2017 CNT 166, a contract with Centennial Mental Health Center, Inc. Ms. Frenier stated this contract is a revised agreement to provide IOG Coordinator and FACT Facilitator the cost of salary, taxes, benefits and operating expenses for 1.5 FTE in the amount not to exceed \$26,469.25 with the term of contract being for three months, July 1, 2017 through September 30, 2017. Ms. Freiner stated this contract utilizes Morgan County Interagency Oversight Group (IOG) funds. Ms. Frenier stated they are currently meeting quarterly, and explained they will be recruiting for a half time facilitator as the current facilitator recently submitted her resignation. She also outlined what the FACT Facilitator assists with. She clarified the language indicated (for interpretation/translation services) explaining this money can be used for language translation.

Commissioner Arndt made a motion to approve Contract 2017 CNT 166 with Centennial Mental Health Center, Inc. using Morgan County Interagency Oversight Group (IOG) funds in the amount not to exceed \$26,469.25 with the term of the contract being from July 1, 2017 through September 30, 2017 as outlined by Morgan County Department of Human Services Director Jacque Frenier along and authorized the Chair to sign. Chairman Zwetzig seconded motion and motion carried 2-0.

#### Consideration of Approval - CONTRACT - 2017 CNT 167 - A Caring Pregnancy Resource Center

Morgan County Department of Human Services Deputy Director Rogelio Segura presented to the Board Contract 2017 CNT 167, a contract with A Caring Pregnancy Resource Center. Mr. Segura stated this contract is to provide services and education related to preventative and pre and postnatal support in the amount of \$9,000.00 with the term of contract July 1, 2017 through June 30, 2018. Mr. Segura stated this contract utilizes TANF funds. Commissioner Arndt asked the question about the amounts being proposed are those that were approved during the recent budget meetings and clarified that the reason this is being processed in this manner is due to the State's fiscal year is different than that of what the County's current fiscal year is with Mr. Segura stating that was correct.

Commissioner Arndt made a motion to approve Contract 2017 CNT 167 with A Caring Pregnancy Resource Center funding source being TANF in the amount of \$9,000.00 with the term of the contract being from July 1, 2017 through June 30, 2018 as outlined by Morgan County Department of Human Services Deputy Director Rogelio Segura and authorized the Chair to sign. Chairman Zwetzig seconded motion and motion carried 2-0.

#### Consideration of Approval - CONTRACT - 2017 CNT 168 - Baby Bear Hugs

Morgan County Department of Human Services Deputy Director Rogelio Segura presented to the Board Contract 2017 CNT 168, a contract with Baby Bear Hugs. Mr. Segura stated this contract is to provide services for new mothers in the amount of \$15,000.00 with the term of contract July 1, 2017 through June 30, 2018. Mr. Segura stated this contract utilizes TANF funds.

Commissioner Arndt made a motion to approve Contract 2017 CNT 168 with Baby Bear Hugs funding source being TANF in the amount of \$15,000.00 with the term of the contract being from July 1, 2017 through June 30, 2018 as outlined by Morgan County Department of Human Services Deputy Director Rogelio Segura and authorized the Chair to sign. Chairman Zwetzig seconded motion and motion carried 2-0.

#### Consideration of Approval - CONTRACT - 2017 CNT 169 - Goodwill Industries of Denver

Morgan County Department of Human Services Deputy Director Rogelio Segura presented to the Board Contract 2017 CNT 169, a contract with Goodwill Industries of Denver. Mr. Segura stated this contract is to provide life skills and career development in the amount of \$50,400.00 which is \$4,000.00 per month plus \$200.00 rent reimbursement with the term of contract July 1, 2017 through June 30, 2018. Mr. Segura stated this contract utilizes TANF funds and indicated they are located at the Life Fellowship facility.

Commissioner Arndt made a motion to approve Contract 2017 CNT 169 with Goodwill Industries of Denver funding source being TANF in the amount of \$50,400.00 which is \$4,000.00 per month plus \$200.00 rent reimbursement with the term of the contract being from July 1, 2017 through June 30, 2018 as outlined by Morgan County Department of Human Services Deputy Director Rogelio Segura and authorized the Chair to sign. Chairman Zwetzig asked if this organization has met with the other counties to request funding with Ms. Jacque Frenier stating she knows this is a goal of theirs as they do provide services to all the northeast counties. Chairman Zwetzig asked Ms. Frenier to provide an update to the Board regarding this information. Chairman Zwetzig seconded motion and motion carried 2-0.

Mr. Segura stated this contract is to provide services for victims of domestic violence in the amount of \$30,000.00 with the term of contract July 1, 2017 through June 30, 2018. Mr. Segura stated this contract utilizes TANF funds.

Commissioner Arndt made a motion to approve Contract 2017 CNT 173 with S.H.A.R.E. Inc. funding source being TANF in the amount of 30,000.00 with the term of the contract being from July 1, 2017 through June 30, 2018 as outlined by Morgan County Department of Human Services Deputy Director Rogelio Segura and authorized the Chair to sign. Chairman Zwetzig seconded motion and motion carried 2-0.
