The Board of Morgan County Commissioners met Tuesday, August 18, 2020 at 9:15 a.m. with Chairman Mark Arndt, Commissioner James Zwetzig and Commissioner Jon Becker in attendance.

Commissioner Zwetzig made mention about item #7 that there will be the public opportunity for bid of a building owned by the County, with the letter of engagement being for an appraisal process of this building.

Commissioner Zwetzig made a motion to approve items 1-8 as presented noting the correction to the presented agenda regarding #8 to reflect it being Wakefield & Associates as well as the details of Item #7, with Commissioner Becker seconding the motion and the motion carried 3-0.

GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

Consideration of Approval – MORGAN COUNTY TOURISM PANEL BOARD APPOINTMENT - Ryan Schwede, Best Western Overland Plus Inn Representative

Commissioner Becker asked the Board to consider the appointment of Ryan Schwede, Representative for the Best Western Overland Plus Inn to the Morgan County Tourism Panel with the appointment to expire on December 31, 2020 and made a motion to this affect. Commissioner Zwetzig seconded the motion and motion carried 3-0.

Consideration of Approval – Finance Department Audit Report –Kelly Watson, County Auditors Watson Coon Ryan L.L.C.

Ms. Covelli presented stating the County did undergo the audit for this year and introduced Kelly Watson, County Auditor with Watson Coon Ryan L.L.C. who presented to the board the county audit. Ms. Watson summarized the annual audit to the Board outlining each fund and departmental budgets and procedures. She stated the County was

very responsive and helpful making the audit process easy and efficient. She stated there were no findings that would require the Board's attention. She further discussed some findings that could be improved upon. Ms. Watson then summarized the communication letter with the Board explaining what the information referenced. She further spoke about one item of non-compliance found in the Solid Waste Fund and summarized the finding explaining that this has been corrected and standards have been put in place as necessary with no correction needed at this time.

Operational requirements were discussed for the following departments, naming the Extension Office as one department, and stating they have implemented some good procedures, and operationally provided some suggestions. The Treasurer's Office was then discussed, where Ms. Watson summarized the item there is a check threshold and no requirement of segregated duties, explaining it is a low dollar amount, and noted what they felt could be implemented operationally. She recommended spot checks be completed on small amount checks as an added control. Overall, she stated it was a very clean and easy audit and did not see anything particularly concerning.

Chairman Arndt stated no official action will be taken regarding the audit at this time, this will be scheduled for next week's agenda, given it was not posted as an official action for today's agenda, and further stated he will not be present but is very happy with the job that has been done and pleased with the financial department, and praised them for their work and how fortunate to have the financial staff the County has as well as the IT Department as well as the department heads that are responsible for expenditures and reviewing their individual budgets.

Ms. Covelli stated she has nothing further to add and thanked her staff and IT for their assistance and feels they have a good working relationship with the auditors, and has no concerns.

Commissioner Zwetzig asked that this be available on the county's website with Ms. Kopetzky stating it is available and it can be accessed by clicking on the finance page, and the link that indicates "2019 CAFR".
