A RESOLUTION TO CANCEL PROPERTY TAXES ON REMOVED, DESTROYED, OR ABANDONED REAL PROPERTY AND PERSONAL PROPERTY

WHEREAS, pursuant to C.R.S. § 39-10-114(2)(a), Morgan County may cancel any taxes levied on personal property, including but not limited to mobile homes, which are determined to be uncollectible after a period of one year after the date of their becoming delinquent;

WHEREAS, the Morgan County Treasurer has determined that certain properties more particularly described in **Exhibit A**, attached hereto and incorporated herein by this reference (the "Properties"), have been removed, destroyed or abandoned.

NOW THEREFORE be it resolved by the Morgan County Board of County Commissioners as follows:

- 1. Property taxes on the Properties described in **Exhibit A** are uncollectable.
- 2. Property taxes on the Properties described in **Exhibit A** are cancelled.

Morgan County Treasurer and Public Trustee, Bob Sagel, presented to the Board Resolution 2020 BCC 28 a Resolution To Cancel Property Taxes On Removed, Destroyed Or Abandoned Real Property And Personal Property. Mr. Sagel stated there are a total of five that will be canceled and summarized each one in detail and asked the Board to approve the resolution as presented in the amount of \$1,371.40 as being declared uncollectable or void and to be cancelled.

Commissioner Zwetzig made a motion to approve Resolution 2020 BCC 28 a Resolution To Cancel Property Taxes On Removed, Destroyed Or Abandoned Real Property And Personal Property with Chairman Arndt seconding the motion. At this time, the motion carried 2-0.

COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS

Morgan County Treasurer Bob Sagel provided an update regarding the collection of property taxes and where the County stands at this time as well as the County's investment status with the anticipation that the interest received on the investments will be considerably lower for the 2021 budget year.

Morgan County Clerk Susan L. Bailey provided an update regarding the upcoming 2020 General Election and announced the closure of the Motor Vehicle Department and Recording Department on Election Day.

Morgan County Human Resources Director Tracy Amen updated the Board regarding the number of positions open at this time, explaining those vacancies asking for interested parties to apply.

Kristin Clifford-Basil, Director of Morgan County Economic Development Corporation, provided an update regarding the grant process and the clarification for the process comes from the state and federal guidelines, not the County Commissioners. Chairman Arndt reiterated the guidelines set by the State that the County must follow and

the County is doing their very best to follow these guidelines and need the clarification from the State in order to distribute these grant funds to businesses. He explained that the monies must be dispersed appropriately to avoid the issue with anyone receiving monies for those expenses that may not be considered eligible and the monies would have to be returned.

Commissioner Arndt presented the road report ending September 18, 2020 reading the report into the minutes and also encouraged citizens to apply for the open positions available in the various Morgan County departments.

Commissioners reviewed the calendar dated September 18, 2020 through September 29, 2020 with no changes.

Commissioner Zwetzig asked citizens to be mindful that the County is experiencing staffing shortages, and asked for patience during this challenging time, and asked citizens to thank those for doing a good job and commended the staff for doing a good job during an unknown era.

Chairman Arndt asked if there was any further business to bring before the Board, and upon hearing none, the meeting was adjourned at 9:19 a.m.
