### **RESOLUTION 2020 BCC 29**

A RESOLUTION CONDITIONALLY APPROVING A TWO LOT MINOR SUBDIVISION LOCATED IN THE  $5\frac{1}{2}$  OF SECTION 34, TOWNSHIP 5 NORTH, RANGE 59 WEST OF THE  $6^{th}$  P.M. MORGAN COUNTY, COLORADO TO BE KNOWN AS THE DEGANHART MINOR SUBDIVISION.

**WHEREAS,** Kimberlee Deganhart (the "Owner") owns property located in the  $S\frac{1}{2}$  of Section 34, Township 5 North, Range 59 West of the  $6^{th}$  P.M. Morgan County, Colorado, (the "Property");

**WHEREAS**, Lindsey Deganhart (the "Applicant"), on behalf of the Owner, applied for approval of the Deganhart Minor Subdivision (the "Application");

**WHEREAS**, on August 10, 2020, the Morgan County Planning Commission held a duly noticed public hearing on the Application where they received public comment, staff input and recommended approval of the Application;

**WHEREAS**, on September 14, 2020, the Board of County Commissioners (the "BOCC") held a duly noticed public hearing on the Application;

**WHEREAS,** during the public hearing, the BOCC received testimony and evidence from the Applicant, Morgan County staff and the public; and

WHEREAS, after considering all relevant testimony and evidence, the BOCC desires to approve the Application.

# NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MORGAN COUNTY, COLORADO:

- 1. The BOCC, having reviewed the application, all information provided and testimony heard, finds that:
  - a. The Application documents are complete and represent how the subdivision will be laid out including infrastructure, easements and access.
  - b. The subdivision is in conformance with the Morgan County Comprehensive Plan and there is access to established public infrastructure.
  - c. The subdivision is compatible with surrounding land uses.
- 2. The BOCC hereby approves the Deganhart Minor Subdivision located in the S½ of Section 34, Township 5 North, Range 59 W of the 6<sup>th</sup> P.M. Morgan County, Colorado subject to:
  - a. Morgan County Quality Water tap will be paid in full prior to recording the plat.

### Consideration of Approval – Bid Tabulations – RFP 2020-0915-001 Proximity Door System and Door Alarm

Morgan County Building Maintenance Director, Dave Cornwell presented to the Board for approval bid award RFP 2020-0915-001 Proximity Door System and Door Alarm. Mr. Cornwell stated he received two bids from Long Building Technologies, in the total amount of \$29,196.00 and from Door Security in the total amount of \$26,000.00. Mr. Cornwell stated this will be a card system for the doors at the Administration Building.

At this time, Mr. Cornwell asked the Board to award the bid to Long Building Technologies, in the total amount of \$29,196.00. Mr. Cornwell stated that Long Building Technologies is the current vendor for the DHS building and will soon be working with the Sheriff's office as well. The completion date will be December 11, 2020.

Morgan County Emergency Management Director, Roger Doll explained that the County received an Emergency Performance Grant from the State of Colorado Division of Homeland Security and Emergency Management in the amount of \$11,555.00. This grant will help cover a portion of the cost of the door system and will be reimbursed to the County once the project is completed.

Commissioner Zwetzig made a motion to approve the Emergency Performance Grant from the State of Colorado Division of Homeland Security and Emergency Management in the amount of \$11,555.00 and approve the bid award RFP 2020-0915-001 Proximity Door System and Door Alarm to Long Building Technologies as recommended by Morgan County Building Maintenance Director, Dave Cornwell in amount of \$29,196.00 and authorized the Chairman to sign. Commissioner Becker seconded the motion. At this time, the motion carried 3-0.
