BOARD OF COUNTY COMMISSIONERS Minutes of Meeting January 9, 2018

The Board of Morgan County Commissioners met Tuesday, January 9, 2018 at 9:00 a.m. with Chairman James Zwetzig, Commissioner Laura Teague and Commissioner Mark Arndt in attendance. Chairman James Zwetzig asked those deputies who were scheduled to be sworn in this morning to lead the meeting in the Pledge of Allegiance.

ADOPTION OF THE AGENDA

Commissioner Teague made a motion to revise the agenda by moving the swearing of the Morgan County Sheriff's deputies, Item E, to commence prior to the reorganization of the board, with Commissioner Arndt seconding the motion. Motion carried 3-0.

Commissioner Teague made a motion to approve the agenda as revised, with Commissioner Arndt seconding the motion and motion carried 3-0.

At this time, Sheriff Crone asked seven new deputies to come to the front and read aloud the oath of office. Those deputies sworn in introduced themselves by providing their background. Those deputies sworn in were Deputy Jim Parks, Deputy Steve Berlanga, Deputy Matt Ryan, Deputy Eduardo Rios, Deputy Ashley Warren, Deputy Hilary Leake, and Deputy Alexandria Martinez.

Sheriff Crone indicated that all staff are sworn in as deputy sheriff officers and explained those responsibilities afforded to them when on active duty. He stated everyone takes the same oath of office regardless of their certification. He further indicated they have 50 uniformed staff with 30 of those being in the jail and the remainder on patrol and in the front office.

REORGANIZATION OF THE BOARD

At this time, Chairman Zwetzig turned the meeting over to Clerk and Recorder Susan Bailey who called the organization meeting to order and inquired if there was any old business for the Board to act upon with Chair Teague stating none. Ms. Bailey then entertained a motion to sine die with Commissioner Teague making the motion, Commissioner Arndt seconding the motion and motion carried 3-0.

Morgan County Public Works Director Bruce Bass presented to the Board for approval, an Intergovernmental Agreement, 2018 IGA 01 Regarding extraction of gravel with Washington County. Mr. Bass stated the purpose of this IGA is to alleviate time, costs, wear and tear for both Morgan County and Washington County. He stated Morgan County will pull form one of their pits located in the southeastern portion of the county and currently are having to pull form the northeastern corner, so this will alleviate the travel and time issues. Washington County will utilize our location to alleviate the costs for hauling gravel to their locations.
