WHEREAS, Sterling Energy ("the Owner") owns property located in the E½ of Section 27, Township 6 North, Range 59 West of the 6th P.M. Morgan County, Colorado and addressed as 31405 County Road 10, Weldona, Colorado 80653;

WHEREAS, the Owner submitted a request for a three-year vesting extension a Special Use granted on November 18, 2014 pursuant to Resolution 2014 BCC 34, Reception Number 890663;

WHEREAS, the Board of County Commissioners received testimony and evidence from the applicant; and

WHEREAS, the Board of County Commissioners received the testimony of the Morgan County Planning Administrator.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MORGAN COUNTY, COLORADO:

- The Board of County Commissioners, having reviewed the application, all information provided, testimony heard and the criteria for the extension of vesting as set forth in Sections 2-435 and Section 2-445 of the Morgan County Zoning Regulations desires to approve the vesting request. Nothing in this Resolution shall be deemed to affect the validity or terms of Resolution 2014 BCC 34, recorded at reception number 890663 on November 18, 2014.
- 2. Vesting is granted for an additional three years that will terminate on November 21, 2020.
- 3. County staff is directed to publish notice of the vested rights as required by StateLaw.

GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

Consideration of Approval – RIGHT OF WAY - 2018 PMT 07 – Xcel Energy

Morgan County Road Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2018 PMT 07, with Xcel energy. Mr. Goodman stated this right of way permit is to bore under County Road R (Morgan County Road Segment 1700), starting at the gas main in the south right of way of County Road R located south of the property address of 26089 County Road R boring north under County Road R to the north right of way of County Road R, for the purpose of installing a gas service. He stated the fees are attached in the amount of \$150.00 and the location has been inspected.

Commissioner Teague made a motion to approve Right of Way Permit 2018 PMT 07, with Xcel Energy as outlined in the narrative of the permit noting the fees in the amount of \$150.00 are attached as presented by Morgan County Road Supervisor John Goodman and authorized the Chair to sign. Commissioner Zwetzig seconded the motion. At this time, the motion carried 3-0.

Consideration of Approval - RIGHT OF WAY - 2018 PMT 08 - Xcel Energy

Morgan County Road Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2018 PMT 08, with Xcel energy. Mr. Goodman stated this right of way permit is to cross overhead of County Road R (Morgan County Road Segment 1700), starting at the intersection of County Road 26 and in the south right of way of County Road R a distance of 270 feet east on County Road R replacing an existing power pole with new power pole, for the purpose of installing new wire and replacing existing power pole at an address of 26089 County Road R. He stated the fees are attached in the amount of \$150.00 and the location has been inspected.

Commissioner Zwetzig made a motion to approve Right of Way Permit 2018 PMT 08, with Xcel Energy as outlined in the narrative of the permit noting the fees in the amount of \$150.00 are attached as presented by Morgan County Road Supervisor John Goodman and authorized the Chair to sign. Commissioner Teague seconded the motion. At this time, the motion carried 3-0.

Presentation of Annual Report for the East Morgan County Library - Laura McConnell, MLS Director of **East Morgan County Library**

MLS Director of East Morgan County Library, Laura McConnell was presented at this time with Commissioner Zwetzig stating that if Ms. McConnell should arrive she they will return to this portion of the meeting. With the Board in agreement.

COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS

Commissioners reviewed the calendar dated February 9, 2018 through February 20, 2018 with no changes.

Administrative Services Manger Kristi Waite stated that MLS Director of East Morgan County Library, Laura McConnell was to be placed on next week's agenda not this week there was a communication error.

UNFINISHED BUSINESS

There was no unfinished business.

CITIZEN'S COMMENT

Chuck Miller, 26060 Morgan County Road S Brush CO, stated that last night at the Planning Commission meeting they were challenged with reviewing the floodplain regulations and the changes within the County comprehensive land use plan in which he was in attendance. He would like to point out a couple things pursued to Title 29 Article 20 Title 30 Article 28 of the Colorado Revised Statues, The State of Colorado has designated to counties the responsibility to adopt regulations designed to minimize the flood losses.

Mr. Miller also stated that the meeting went on to present the resolution where as in order to participate in the Nation Flood Insurance Program the County must adopt a new flood insurance safety, FIS, and flood insurance rate map, FIRM, created by FEMA. Whereas the County FIS and FIRM had been recently updated by FEMA and the county desires to adopt the map in order to maintain the ability of its citizens, to obtain the flood insurance and to maintain the County's continued ability to receive federal grants and funding related to the flood plain management.

Mr. Miller continued to present the definitions to be repealed or moved, and stated that he would like to point out that it was presented last night that these were to be moved. This portion has to do with permitting process through FEMA under 1375 development. The construction of substantial improvement on land parcels and buildings or other structures for residential, institutional commercial, industrial, agricultural, transportation, public flood control, utilities, recreational, and similar uses, in contrast to use of the land for growing crops, truck, gardening, grazing, farm animals and other agricultural production pursuits. The terms also applies to vacant ground which has been or is being prepared for development by such steps as instillation of water or sewer lines, construction of railroad spur or branch tracks or construction of railroad utility facilities also included are other activities such as mining, lot graining, filling, bridge development, and storage of equipment and materials. Mr. Miller continues to state that it was presented last night that the Planning and Zoning Commission in December when they first looked at these made a recommendation that anything to do with agriculture production will be exempt from a FEMA permit of any kind. It was told last night by Planning and Zoning Administrator, Pam Cherry, that in contrast too, means that it is exempt, and when you look up the definitions it means something different.

Mr. Miller has a major concern in why the legal council chose the phrase in contrast to instead of exemption. Mr. Miller strongly suggests that the county does not agree to having to get a permit of any kind to blade roads in a flood plain. Morgan County knows how to handle roads in the floodplain. Mr. Miller stated that that if this is to be repealed or removed then it must be repealed the whole thing must repealed and must start over. Mr. Miller believes that major mistakes are being made and understand that they have until April 4th to deal with this or there will be violations. The County attorney must listen to the citizens and the County Attorneys job is to make sure the County does things legally but is required to do what the citizens want done.

Mr. Miller stated that Ms. Cherry did a great job explaining to the Planning Board know that the Morgan County Commissioner body in 2008 participated in developing a study with FEMA. In 2015 the County Commissioners signed and agreed to the rules and regulations and he believes it was without complete review. He explained that it is this commissioner body that is required by April 4th to adopt them and he hope they do not.

At this time, Chairman Arndt presented Commissioner Zwetzig with a gift and explained that he is a traditionalist and in 1995 he received his first gift and explained it is a honor to serve as the Chairman of the Board of County Commissioners. Chairman Arndt stated John Crosthwait started this tradition with it being that when a Chairman retires they are presented with a gift. Commissioner Zwetzig thanked the Board for the gift of a gavel that can have more dates added to if he is ever the Chairman of the Board in the future.

Being no further business the meeting was then adjourned at 9:16 a.m..
