#### BOARD OF COUNTY COMMISSIONERS Minutes of Meeting May 15, 2018

The Board of Morgan County Commissioners met Tuesday, May 15, 2018 at 9:06 a.m. with Chairman Mark Arndt, Commissioner Laura Teague and Commissioner Zwetzig in attendance. Chairman Arndt asked Morgan County Human Resource Director Tracy Amen to lead the meeting in the Pledge of Allegiance.

#### **ADOPTION OF THE AGENDA**

Commissioner Zwetzig made a motion to adopt the agenda as presented, with Commissioner Teague seconding the motion. Motion carried 3-0.

#### **CONSENT AGENDA**

Ratify the Board of County Commissioners approval of meeting minutes dated May 8, 2018

Commissioner Teague made a motion to approve all items on the Consent Agenda as presented. Commissioner Zwetzig seconded the motion and motion carried 3-0.

#### GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

#### Consideration of Approval - BID AWARD - RFP 2018- 0426-001 Salary Study

Morgan County Human Resources Director Tracy Amen presented to the Board for approval Bid Award RFP 2018-0426-001 Salary Study. Ms. Amen stated she received ten bids from GovHR, Lee & Burgress, CPS HR, The Mercer Group, Pontifex, HRCC HR Compensation, Evergreen, Paypoint HR, Accomplished and Segal Waters Company. Ms. Amen summarized each bid stating they ranged from \$10,500 to \$42,500 and in regards to her recommendation for bid award, focused on the lowest five bids due to county budget constraints. Ms. Amen stated she did check references and recommended the bid be awarded to CPS HR, in the amount not to exceed \$19,730.00 stating her reasons as being this company has a strong presence in Colorado, references were very strong and the experience in local government salaries appears to be strong as well.

Commissioner Teague asked what the completion date will be with Ms. Amen stating it will be completed by July 2018 in order to provide the data for consideration at the time of budget preparations. Commissioner Zwetzig asked about the statement made regarding there will be employee interviews conducted by this vendor and feels that this will be positive. It was discussed that the benefit compensation package will also be reviewed and studied.

Commissioner Teague made a motion to approve bid award RFP 2018-0426-001 Salary Study to CPS HR in an amount not to exceed \$19,730.00 and authorized the preparation of a contract as outlined and recommended by Ms. Amen. Commissioner Zwetzig seconded the motion and the motion carried 3-0.

#### Presentation of Award - 2018 GRA 08 Bloedorn Foundation

Morgan County Ambulance Director Joe King presented to the Board an award 2018 GRA 08 Bloedorn Foundation. Mr. King stated he has been looking at obtaining the power cots due to employee safety and explained this will alleviate costs to the county for back injuries and these have become the standard of care further stating they are quite expensive. Due to the cost, he stated he has reached out to various foundations and one of those was the Bloedorn Foundation who graciously has offered \$35,000 towards the purchase of these cots expressing his appreciation of this contribution.

Chairman Arndt stated the County is fortunate to have these foundations and expressed his gratitude to these foundations for awarding these funds towards these types of purchases.

Commissioner Zwetzig made mention of the property located at 623 Edison, Brush Colorado which is currently listed on the County's website for sale stating any interested party may submit a bid to the County Commissioners office no later than June 8, 2018 at 4 p.m.. He indicated that he is hopeful this will allow for some funds to be given back to the ambulance enterprise fund to help with the costs of these cots as well.

Commissioner Teague expressed her gratitude to Mr. King for finding ways to obtain funding for the costs of these cots, and appreciates the efforts he has made to make this purchase.

Mr. King stated this purchase will also allow for retention of recruitments as it does allow for a safer environment and ease of operations.

#### Consideration of New Fireworks Display application

Morgan County Administrative Services Manager Kristi Waite presented to the Board for approval of a new Fireworks Display application. Mr. Waite stated a packet of information has been drafted which allows for complying with state statute and regulations which requires someone with a pyrotechnic certification to be able to conduct an event including a fireworks display.

Commissioner Zwetzig stated he has spoken with the Fort Morgan Fire Department Administration office and was told they have individuals who have completed certification for this type of service.

Chairman Arndt read aloud the instructions of the permit application being presented at which time Commissioner Teague made a motion to approve the new Fireworks Display application as outlined by Ms. Waite and read aloud by Chairman Arndt. Commissioner Zwetzig seconded the motion and the motion carried 3-0.

It was noted this information will be available on the County's website and Commissioner Zwetzig asked that the media make note of this information.

#### **COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS**

Commissioners reviewed the calendar dated May 11, 2018 through May 22, 2018 with changes.

Jacque Frenier, Morgan County Department of Human Services Director stated that May is foster care recruitment retention month and asked to support the County's foster parents. She further spoke about upcoming trainings that are being offered for foster and kinship families as well as other events that are currently scheduled to observe foster care providers naming those who will be retiring from foster care in the near future. Discussion followed with the Board expressing their appreciation to those who provide these services in the County.

Susan Bailey, Morgan County Clerk and Recorder provided an update in regards to the upcoming 2018 Primary Election noting ballots will be sent to voters the week of June 4, 2018 and other pertinent information. Commissioner Zwetzig made mention of a recent article which commended the State of Colorado and its election officials for maintaining the integrity of the election system and expressed his appreciation and praise of the individual County Clerk and the election staff for Morgan County.

#### **UNFINISHED BUSINESS**

Chairman Arndt stated at a prior meeting a request was made by citizen, Durwood Darbin made a request to vacate County Road O west of Highway 52 to the dead end and that was done in citizen's comment, and asked if there is any consideration to this request or any action to be taken.

Commissioner Teague made the motion to decline the consideration of this request for vacation of County Road O because it is not in the best interest of landowners that might utilize the road to access their adjacent properties, with Commissioner Zwetzig seconding the motion. Chairman Arndt asked to add the requirement to instruct Administrative Services Manager Kristi Waite to send Mr. Darbin a letter notifying him of the Board's decision to decline this request for the reasons stated. At this time, the motion carried 3-0.

#### **CITIZEN'S COMMENT**

There was no citizen comment provided.

#### PUBLIC HEARING - continued from April 24, 2018

Chairman Arndt called the hearing to order at 9:30 a.m. in the Assembly Room of the Morgan County Administration Building. Present were Chairman Mark Arndt, Commissioner Laura Teague and Commissioner James Zwetzig in attendance. Also present was Pam Cherry, Planning Administrator.

Consideration for Approval – Amending various sections of the Morgan County Zoning Regulations concerning the use of property by Oil and Gas Operations

Chairman Arndt asked Ms. Cherry to present the matter with Ms. Cherry stating the Planning Commission met on March 12, 2018 in regards to amending various sections of the Morgan County Zoning Regulations concerning the use of property by Oil and Gas Operations and further indicated that a stakeholders process has been held whereas these proposed regulations have been significantly revised. She recommended that the revised regulations now be sent back to the Planning Commission for their review on June 11, 2018 and this matter be continued for a later date.

Commissioner Teague made a motion to refer the various sections of the Morgan County Zoning Regulations concerning the use of Oil and Gas operations back to the Planning Commission to be heard by them on June 11, 2018. Commissioner Zwetzig seconded the motion. At this time, Chairman Arndt asked if there has been a request from the stakeholders to hold another meeting after the Planning Commission reviews the regulations, with Ms.

Cherry stating the revised regulations will be sent to the stakeholders for their review and possible comment. At this time, the motion carried 3-0.

Being no further business the meeting was then adjourned at 9:32 a.m.
