GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

Consideration of Approval - RIGHT OF WAY - 2018 PMT 20 - Xcel Energy

Morgan County Road Supervisor John Goodman presented to the Board for approval, a Right of Way Permit 2018 PMT 20, with Xcel Energy. Mr. Goodman stated this right of way permit is to bore in the north right of way of Yates Terrace (Road Segment 200), starting approximately 20 feet south of the north right of way at the east end of the cul-de-sac of Yates Terrace and boring north to the east wall of the residence, for the purpose of installing a new residential gas service. He stated the fees are attached in the amount of \$150.00 and the location has been inspected.

Commissioner Teague made a motion to approve Right of Way Permit 2018 PMT 20, with Xcel Energy as outlined in the narrative of the permit noting the permit is for a residential gas service further noting the fees in the amount of \$150.00 are attached as presented by Morgan County Road Supervisor John Goodman and authorized the Chair to sign. Chairman Arndt seconded the motion. At this time, the motion carried 2-0.

COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS

Morgan County Treasurer and Public Trustee Bob Sagel presented to the Board the Morgan County Treasurer's First Quarter Report for 2018. Mr. Sagel provided information detailing the first quarter report to the Board and further summarized the data highlighting the fact that overall the total investments have increased since this same time period as last year.

Commissioner Teague made a motion to accept Morgan County Treasurer's report as submitted by Treasurer and Public Trustee Bob Sagel. Chairman Arndt seconded the motion and motion carried 2-0.

Commissioners reviewed the calendar dated May 18, 2018 through May 29, 2018 with no changes.

Updates were provided by both Morgan County Clerk Susan Bailey as to the upcoming Primary Election and the new software system being implemented in the Motor Vehicle Department as well as Road Supervisor John Goodman who stated he believes the summer schedule that has been implemented seems to be working well.
