Chairman Pro Tem Mark Arndt asked Morgan County Information Systems Manager Karol Kopetzky to lead the meeting in the Pledge of Allegiance.

Licensee: Schiel, Roger P. - Hamlin, John H. dba The Last Stand

Operating Manager: Roger Schiel

Chairman Pro Tem Arndt opened the matter for public comment at which time no comment followed.

Morgan County Clerk Chief Deputy Clerk, Randee Aleman presented to the Board a Liquor License Renewal Application submitted by Roger P. Schiel and John H. Hamlin, dba The Last Stand for a Fermented Malt Beverage On/Off Premises (County). Ms. Aleman stated that she has received the necessary documents and all fees have been submitted. Ms. Aleman stated that with Senate Bill 19-028 passing allowing businesses to keep their on/off premises licenses. The Last Stand is located in a rural area with town population of less than 7,500 people. Ms. Aleman stated she has had no issues with this licensee and then asked the Morgan County Sheriff's Department to report at which time Sheriff Martin indicated he had nothing to report. Ms. Aleman then asked the Board for approval of this license renewal.

Commissioner Becker asked if the current liquor license will move across and if they to be able still serve the to go six packs and serve in the bar as well, with Ms. Aleman stating that was correct.

Chairman Pro Tem Arndt seconded the motion and motion carried 2-0.

COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS

Commissioners reviewed the calendar dated March 1, 2019 through March 12, 2019 with changes.

Commissioner Becker stated that he has been getting numerous calls on the Red Flag or Extreme Risk Protection Order Bill, House Bill 1177. He explained that the Commissioners have not spoken on this, there was to be a Second Amendment Group to speak to the Board today however they are not here. He explained that he has reservations when counties start passing resolutions to say that they will follow the Constitution, when all elected officials take an oath stating they will uphold the federal and state constitutions. He stated he is disappointed in the State Legislature regarding the bill which is being presented is way different than what was proposed last year. Commissioner Becker stated that the current version of the bill violates numerous Constitutional laws that citizens are protected under. He stated that if the State of Colorado is worried about mental health they should use the billion dollar surplus they have and start putting it towards addressing of mental health issues.

Sheriff Martin stated he voted against this bill through the County Sheriffs of Colorado Association to not support it as a County Sheriff. He stated that the Colorado County Sheriff's Organization is split fifty-fifty so they are taking a neutral stance on the bill. He agrees with Commissioner Becker that this bill is a violation of citizens' rights. He stated that is this bill passes it will not only put a burden on the Sheriffs office but also local law enforcement offices as well.

Chairman Pro Tem Arndt stated he agreed with Commissioner Becker that they have taken their oath and swear to uphold the Constitution and this is clearly a violation of that and hopes that the State of Colorado and the Attorney General challenges this bill.
