The Board of Morgan County Commissioners met Tuesday, July 16, 2019 at 9:07 a.m. with Chairman Pro Tem Mark Arndt and Commissioner Jon Becker in attendance with Chairman James Zwetzig absent and excused.

ADOPTION OF THE AGENDA

Consideration of Approval - Request to Vacate Alley, Snyder Bible Church

Chairman Pro Tem Arndt introduced the request from Snyder Bible Church to vacate an alleyway lying between lots on block 8, 22-31 on the north and 20-21 and 12-19 on the south be vacated by the County. Chairman Pro Tem Arndt indicated those requesting this action failed to receive the necessary signatures from the adjoining landowners as required and requested by the County to ensure that those landowners have been given the opportunity to express their support or opposition to this request. He further indicated those requesting this action have asked that this matter move forward today without the required information.

At this time, Commissioner Becker made a motion to deny the request to vacate an alley from the Snyder Bible Church, address being 22622 Fisher Avenue, Snyder, CO, owner of block 8 – 20-29, Chairman Pro Tem Arndt second the motion and motion carried 2-0.
