Commissioner Becker made a motion to approve items 1-11 as presented, Commissioner Arndt seconded the motion and motion carried 3-0.

#### GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

Consideration of Approval – BID AWARD – RSO-0804-001 South Platte River Property

Chairman Zwetzig presented to the Board for approval bid award RSO-0804-001 for Morgan County's South Platte River Property that was up for bid. Chairman Zwetzig summarized the bid process and stated the county received two bids from Larry, Jet and Chase Grooms in the amount of \$186,713.10 and a second bid from Matt Ruder in the amount of \$55,000.00. Chairman Zwetzig stated they did reserve the right to reject or accept the bids submitted, and noted that both of these bids were submitted lower than the appraised value.

Commissioner Arndt made a motion to reject the bids submitted in reference to RSO-0804-001 AWD South Platte River Property. Commissioner Becker seconded the motion the motion carried 3-0.

#### **UNFINISHED BUSINESS**

There was no unfinished business.

#### **COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS**

Colorado Parks and Wildlife Update Tyler Sewald, Jackson Lake Park Manager provided a power point presentation to the Board as an update of the activities at the Colorado Parks and Wildlife properties in the County as well as challenges they currently are facing and those challenges in the future.

Todd Schmidt, Area Wildlife Manager, from the Brush area, also presented information as to what staff provides to the northeast region, covering six northeast counties, as well as Morgan County explaining several facets of opportunities and services.

Chairman Zwetzig thanked both Mr. Sewald and Mr. Schmidt for their assistance to Morgan County and asked if they would speak further regarding their involvement with Morgan County Tourism. Mr. Sewald further spoke about his collaboration with and serving on the tourism board, stating he believes it has been beneficial to the park explaining the reasons and how they fit into the community when it comes to tourism. Discussion followed regarding the county's growth and those representing the park what needs they may see. Mr. Sewald stated they have a good relationship with Jackson Lake Village and spoke about a number of things they have worked collaboratively on. He spoke about new homes that are being built and feels the County should look at this to ensure zoning regulations are being met as they experience growth. He also spoke about trespassing issues that have occurred and the issue with educating those who visit the area so they know what access is allowable. Mr. Sewald stated he will continue to be active in regards to this growth and work with the planning department as necessary.

Further discussion followed regarding wildlife area and the habitat needed for animals as well as the subject of flood resiliency. Mr. Schmidt spoke about the South Platte Master Plan and provided an overview of information regarding their attempt to mitigate issues.

Commissioners reviewed the calendar dated August 9, 2019 through August 20, 2019 with no changes.

Being no further business the meeting was then adjourned at 9:29 a.m.
