The Board of Morgan County Commissioners met Tuesday, September 17, 2019 at 9:11 a.m. with Chairman James Zwetzig and Commissioner Mark Arndt in attendance with Commissioner Jon Becker absent and excused.

Commissioner Arndt made a motion to approve items 1-14 as presented, Chairman Zwetzig seconded the motion. At this time the motion carried 2-0.

GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

Consideration of Approval – BID AWARD – RFP 2019-0912-001– Rock Crushing Equipment Rental

Morgan County Road Supervisor John Goodman presented on behalf of Public Works Director, Bruce Bass to the Board for approval Bid Award RFP 2019-0912-001– Rock Crushing Equipment Rental. Mr. Bass stated he received three bids from Wagner Equipment, Power Equipment Company and 4 Rivers Equipment and summarized each bid in detail.

At this time, Mr. Goodman recommended to the Board to award the bid to the lowest bidder 4 Rivers Equipment explaining the equipment can produce the same output as well as the consideration of the wear parts being reviewed.

Commissioner Arndt made a motion to approve bid award RFP 2019-0912-001– Rock Crushing Equipment Rental to 4 Rivers Equipment as outlined and recommended by Morgan County Road Supervisor John Goodman. Chairman Zwetzig seconded the motion. Chairman Zwetzig made comment regarding the reason why the County is proceeding to rent the equipment to crush asphalt, given the cost savings and the unavailability of the adequate material. At this time, the motion carried 2-0.

Consideration of Approval – BID AWARD – RFP 2019-0912-002– Fuel Bid

Morgan County Road Supervisor John Goodman presented on behalf of Morgan County Public Works Director, Bruce Bass to the Board for approval Bid Award RFP 2019-0912-002—Fuel Bid. Mr. Goodman stated three bids were received from Fuelco Energy, LLC, Hill Petroleum and Fuelco Energy and summarized each bid in detail.

At this time, Mr. Goodman recommended to the Board to award the bid to the lowest bidder, Hill Petroleum, with pricing to include delivery to all locations. Mr. Goodman indicated those departments and entities that currently use the fuel site and benefit from this collaborative pricing. Commissioner Arndt noted the bid is for the delivery costs over the daily rack pricing.

Commissioner Arndt made a motion to approve bid award RFP 2019-0912-002—Fuel Bid to Hill Petroleum as outlined and recommended by Morgan County Road Supervisor John Goodman in the amount of \$11,829.10. Chairman Zwetzig seconded the motion. At this time, the motion carried 2-0.

At this time, Chairman Zwetzig asked Commissioner Arndt to present the weekly road and bridge report at which time he summarized those projects being completed.

Consideration of Approval - Board of Equalization Arbitrator consideration of Robert Pennington

Chairman Zwetzig presented to the Board the consideration of Robert Pennington being the Board of Equalization Arbitrator. Chairman Zwetzig stated the County has two names on its arbitration list and have had a request from a taxpayer who wishes to proceed with the arbitration process, and the Board would like to appoint Robert W. Pennington to be a member of that board.

Commissioner Arndt made a motion to approve Robert W. Pennington to be a certified appraiser to represent the County as a member of the Board of Equalization Arbitrator. Chairman Zwetzig seconded the motion. At this time, the motion carried 2-0.

At this time, Information Systems Manager Karol Kopetzky provided an update regarding the upgrade to the sound system for the recordings of the meetings held by the County.
