

# COMMISSIONERS PROCEEDINGS 1

## BOARD OF COUNTY COMMISSIONERS Minutes of Meeting October 1, 2019

The Board of Morgan County Commissioners met Tuesday, October 1, 2019 at 9:01 a.m. with Chairman James Zwetzig and Commissioner Mark Arndt in attendance with Commissioner Jon Becker being absent and excused. Chairman Zwetzig asked Darlene Carpio, Representative of Senator Cory Gardner, to lead the meeting in the Pledge of Allegiance.

### CITIZEN'S COMMENT

Kay Knight, Brush, Colorado, spoke regarding concerns about intersection safety located in the Munn's Addition. Discussion followed with Chairman Zwetzig stating he would agree there are issues and it would be up to the landowner to remove the trees and shrubs with direction from the County and further asked Sheriff Martin for comment on the matter. At this time, Sheriff Martin agreed with Ms. Knight stating there are a lot of trees and refuse in the visual sight at the stop sign intersections and sees that it does create a safety issue. Chairman Zwetzig stated this information should be referred to the Road and Bridge Department for its attention. Discussion followed with Ms. Knight stating she had attempted to contact the Commissioner responsible for this area of the County with no return call. Chairman Zwetzig asked Ms. Knight to provide her contact information to the Administrative Assistant, Karla Powell and the County would be sure to respond to this concern.
