#### **LIQUOR LICENSES**

At this time, the Board of County Commissioners convened as the Morgan County Liquor License Authority in the matters of:

Consideration of Approval – Consideration of Approval – Application for Special Events Permit (Applicant: Center for Healing Trauma and Attachment, Inc., Doreen Hills)

Morgan County Clerk and Recorder Susan Bailey presented to the Board a Special Events Permit submitted by Doreen Hills representing Center for Healing Trauma and Attachment, Inc. Ms. Bailey stated our office has received an application for a special events permit for the Center for Healing Trauma and Attachment, Inc., such event is scheduled for Saturday, October 26, 2019. The application was submitted to our office on September 23, 2019, by event manager, Caitlin Cantrell, who has provided the necessary documentation and payment as required for a special events permit in Morgan County. I have provided a copy of the information to the Board. This matter has been properly posted and all legal requirements have been met which include that of the notice of hearing having been published in the Fort Morgan Times on October 1, 2019 as well as signage having been placed at the location of this event for the required time frame, commencing on September 26, 2019. The pictures have been submitted that shows the signage was posted the ten days prior to the hearing.

Ms. Cantrell has provided documentation from the Manager of the Baymont Inn & Suites confirming the approval of the Center for Healing Trauma and Attachment, Inc. serving and/or selling liquor at the proposed location, Baymont Inn & Suites, located at 14378 Highway 34, Fort Morgan, Colorado. A diagram of the area in which alcohol will be sold and served has also been provided as required.

This permit is being requested for the date Saturday, October 26, 2019 and if approved will be valid for the period of time between 3:00 p.m. and 11:59 p.m.

A background check has been completed for both Ms. Cantrell and Doreen Hills, who is named as the President/Secretary of the organization of this event and no concerns have been reported. Ms. Bailey then asked the Board to follow with the appropriate public hearing process.

Chairman Zwetzig asked Ms. Hills if there was anything she would like to present at which time she indicated she had nothing further to add.

At this time, Chairman Zwetzig opened the matter for public comment with no comment.

Ms. Cantrell provided a summary of the event and commented on what it will benefit indicating it will be a masquerade party, and they have tickets on sale for \$55.00 each. Jacque Frenier, stated she the Department of Human Services does have a CORE contract with the Center for Healing Trauma and Attachment, Inc. and refer Medicaid clients to this agency and has an interest on this non-profit board.

A motion was made by Commissioner Arndt to approve the Special Events Permit submitted by Doreen Hills representing Center for Healing Trauma and Attachment, Inc., on Saturday, October 26, 2019 at Baymont Inn & Suites, located at 14378 Highway 34, Fort Morgan, Colorado as presented by Morgan County Clerk and Recorder Susan Bailey and noting that a receipt of the fees being paid is attached and authorized the Chair to sign. Commissioner Becker seconded the motion and motion carried 3-0.
