She stated the final budget will be presented and adopted on Tuesday, December 12, 2019 at 9 a.m. Ms. Covelli stated the preliminary budget is available on the Morgan County website for review as well as being on file at the Board of County Commissioner's office.

At this time, Chairman Zwetzig opened the matter for public comment at which time there were no public comments made.

Being no further business the meeting was then adjourned at 9:47 a.m.
