BOARD OF COUNTY COMMISSIONERS Minutes of Meeting December 20, 2019

The Board of Morgan County Commissioners met Friday, December 20, 2019 at 9:02 a.m. with Chairman James Zwetzig, Commissioner Mark Arndt in attendance and Commissioner Jon Becker being absent and excused. Chairman Zwetzig asked Morgan County Deputy Clerk to the Board Randee Aleman to lead the meeting in the Pledge of Allegiance.

CITIZEN'S COMMENT

There was no citizen comment provided.

ADOPTION OF THE AGENDA

Commissioner Arndt made a motion to adopt the agenda as presented, with Chairman Zwetzig seconding the motion. Motion carried 2-0.

CONSENT AGENDA

- 1. Ratify the Board of County Commissioners approval of Contract 2020 CNT 011, C.G.R.S. Inc., Term of Contract January 1, 2020 through December 31, 2020
- 2. Ratify Chairman, Commissioner Jim Zwetzig's signature on Image Trend Export Authorization for Clearing House Enrollment and Electronic Data Exchange, signed December 16, 2019
- 3. Ratify the Board of County Commissioners approval of the Warrants for November 2019

Commissioner Arndt made a motion to approve items 1-3 as presented, Chairman Zwetzig seconded the motion. At this time the motion carried 2-0.

GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

Consideration of Approval – 2020 Mill Levy Certification

Morgan County Information Services Director Karol Kopetzky presented to the Board for approval the 2020 Mill Levy Certification for Morgan County. Ms. Kopetzky summarized the information provided to the board stating that all taxing agencies have reported to the County in a timely manner.

Ms. Kopetzky read aloud the school district information certifying the following as:

Merino School District as being 33.813 mills Brush School District as being 50.861 mills Fort Morgan School District as being 40.241 mills Weldona School District as being 31.241 mills Wiggins School District as being 38.136 mills Briggsdale School District as being 19.855 mills Aims Jr. College as being 6.355 mills

Ms. Kopetzky further summarized the mill levy for Morgan County including the cities and towns as:

Morgan County certifying at 28.953 mills City of Brush as being 15.660 mills City of Fort Morgan as being 13.254 mills Hillrose as being 16.515mills Log Lane as being 12.635 mills Wiggins as being 32.212 mills

Further local improvements and service districts were then summarized with the fire districts being referenced as:

Brush Rural Fire as being 3.402 mills Fort Morgan Rural Fire Protection as being 2.994 mills Hillrose Rural Fire as being 7.719 mills New Raymer-Stoneham Fire as being 2.588 mills Wiggins Rural Fire Protection as being 7.000 mills

The following Water Districts were summarized as being:

Morgan Quality Water District as being 0.824 mills Prairie View Ranch Water District as being 0.000 mills

The following Water Conservancy Districts were summarized as being:

Central Colorado Water Conservancy as being 1.286 mills Central Colorado Ground Water Management as being 2.279 mills Lower S. Platte Water Conservation as being 1.000 mills Northern Colorado Water Conservancy as being 1.000 mills Central Colorado Well Augmentation as being 9.034 mills

Ms. Kopetzky then summarized the assessments per acre foot, well or unit as:

Bijou Irrigation as being 19,163 acres at \$46.58/acre
Hillrose Irrigation District 7,359 acres at \$4.50/acre
North Kiowa Bijou Special Association 363 wells \$30.00/each
Northern Colorado Water Conservancy District Class D 451 acres at \$26.70/acre a with an acre foot unit
Riverside Irrigation 22,154 acres at \$4.00/acre an acre foot unit
Weldon Valley Drainage 679 units at \$250.00/unit

Chairman Zwetzig asked if the Roberts 81 Business Improvement District show up on the tax notices, with Ms. Kopetzky stating she is not sure but she can ask the Assessor's office. Ms. Kopetzky explained that it was clarified with DOLA the Roberts 81 Business Improvement District is not on the report submitted due to there being zero assessed value. Ms. Kopetzky explained that Log Lane has lowered their general mill levy in addition to the tax credit and that they have been contacted to let them know that they can raise that back up without that going to a vote with Log Lane stating they understood.

Commissioner Arndt made a motion to approve the certification of Mill Levies as presented to the Board by Morgan County Information Services Director Karol Kopetzky for the tax year 2019 and budget year 2020. Chairman Zwetzig seconded the motion. Motion carried 2-0.

UNFINISHED BUSINESS

There was no unfinished business.

COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS

Karla Powell, Administrative Services Manager stated that the department meetings that were scheduled on December 23, 2019 have been canceled.
