Jon Becker called the meeting to order at 5:30 pm.

NEW BUSINESS

One picture bid from Dustin Price Photography was presented by Jamie Dixon. Cara Draegert made a motion to approve the bid as submitted for Dustin Price to take the 2025 Morgan County Fair Jr. Livestock Sale photos. Jordan Traxler seconded. Motion carried.

Review Fair Special Events and Sponsorships, Jamie Dixon ran through the special events and asked the Board to confirm all dates and times as presented. Also, sponsors and committee members were asked to be confirmed. Jamie Dixon will email list to Jordan Traxler to look over.

EXTENSION REPORTS

Katie Seelhoff, Family Consumer Science and 4-H Specialist reported that she and Jamie Dixon had reviewed the to-do list timeline and along with Grace Wagner, have assembled and mailed out the General and FCS 4-H project packets to all members earlier in the week.

Jamie Dixon, Extension Administrative Tech reported that Fair is a short 60 days away and all 4-H and Open Horticulture Fair award sponsors have been contacted with at 75% confirmation at this time. Looking for approximately six more sponsors to take over for a couple businesses closing. A few suggestions were made by the Board and Jamie will contact.

Marlin Eisenach, Livestock Agent reported that he had contacted an individual that will deliver the pellets to the Fair Grounds at \$4.80 per bag of pellets, which is significantly cheaper than any local dealer. Marlin verified with Mike Cox delivery and storage. Erik Mohrlang volunteered Feldpausch to donate the pallet of shavings that is needed for weigh in areas and night of sale. Jon Becker volunteered Viaero's Van Trailer to transport the savings from Feldpausch to the Fair Grounds. Marlin handed out a comparison summary of 4-H livestock members, see attached report. Marlin talked more about the livestock camps that will be scheduled for the week of June 23rd. All species, dairy, beef, goat, lamb, poultry, rabbit and swine will be covered.

Robin Halley, Extension Director reported that the Morgan County Leaders Advisory Committee helps with reimbursement of up to half of the cost of camps/clinics if the youth is funded. Which means that

the youth must participate in the two fundraisers selling up to 4 items or donate \$25. Clarified the Murdoch's money if not used will go back into the CSU endowment fund to draw interest and will be tied up for up to 8 months. Three Horticulture/4-H Youth Specialist candidates are being scored. Interviews will be held on Tuesday, June 3rd at 8 am for the community involvement. Robin asked for Fair Board members to sit in on the interviews. County Area Directors meeting brought up that there are individuals that are making phone calls to fish for information that can be reported on. Please be careful if you receive a phone call that you don't get trapped. Robin will not be at the July 17th Fair Board meeting, due to Judging another County Fair.
