At this time, Commissioner Westhoff made a motion to approve items 1-17 as presented, Commissioner Arndt seconded the motion. The motion carried 3-0.

GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

Consideration of Approval - Letter of Support, Morgan County Impact Development Funds

Mary Gross, Executive Director of Morgan County Family Center presented to the Board a letter of support. Ms. Gross explained that a resource center has been opened to explore innovative and proven resources in order to connect home buyers with funds and down payment assistance. She stated that the funds would not replace but work with local banks to fill in the gaps that exist. Ms. Gross mentioned that the letter of support would help to get these products and programs locally.

Commissioner Westhoff asked about how it would work with the housing program (House Bill 1281) that was just voted through on November's ballot.

Sue Boyitt stated that they will be working with a variety of partners in Northeastern Colorado to work with potential new funds as effectively as possible.

Commissioner Arndt made a motion to approve the letter of support for Morgan County Impact Development Funds, with Commissioner Westhoff seconding the motion. At this time motion carried 3-0.

OEDIT Presentation – Rural Jump Start Program

Morgan Vankat, Program Manager, Rural Jump Start & Skill Advance, Colorado Office of Economic Development & International Trade presented a presentation in regards to the Rural Jump Start Program. Ms. Vankat explained what the program is and how it affects the community. She stated that the positives to the county would be tax benefits and grant benefits for the business community as well as the people who work for these businesses. These grants include matching grants and new hire benefits. She noted that Northeastern, Eastern, and Southern Colorado have not been very active in the program previously. She explained the rules for applying for and using these benefits.

The commissioners stated they would be interested in seeing what a resolution supporting the program would look like to make a more informed decision.

Consideration of Approval – 2022 Mill Levies Certification For Tax year 2022 and Budget Year 2023

Morgan County Information Services Director, Karol Kopetzky presented to the Board for approval the 2022 Mill Levies Certification for Tax Year 2022 and Budget Year 2023. Ms. Kopetzky summarized the information provided to the board stating that all taxing agencies have reported to the County in a timely manner.

Ms. Kopetzky read aloud the school district information certifying the following as:

Buffalo RE-4 School District as being 31.469 mills
Brush RE-2(J) School District as being 49.099 mills
Fort Morgan RE-3 School District as being 37.731 mills
Weldon Valley RE-20(J) School District as being 27.909 mills
Wiggins RE-50(J) School District as being 39.273 mills
Briggsdale RE-10 School District as being 15.718 mills
Aims Community College as being 6.307 mills

Commissioner Arndt made a motion to approve the school district mill levies as presented by Morgan County Information Services Director Karol Kopetzky, with Commissioner Westhoff seconding the motion. At this time, the motion carried 3-0.

Ms. Kopetzky further summarized the mill levy for Morgan County as:

Morgan County certifying as being 28.983 mills; which includes general fund, road and bridge and social services.

Ms. Kopetzky further summarized the mill levies for Morgan County's cities and towns as follows:

City of Brush as being 15.660 mills City of Fort Morgan as being 13.254 mills Hillrose as being 15.593 mills Log Lane as being 13.094 mills Wiggins as being 32.212 mills

Commissioner Westhoff made a motion to approve Morgan County mill levies, as well as the Morgan County cities and towns mill levies as presented by Morgan County Information Services Director Karol Kopetzky, with Commissioner Arndt seconding the motion. At this time, the motion carried 3-0.

Further local fire districts were then summarized with the fire districts being referenced as:

Brush Rural Fire Protection District as being 3.513 mills Fort Morgan Rural Fire Protection District as being 3.033 mills Hillrose Rural Fire Protection District as being 7.719 mills

New Raymer-Stoneham Fire Protection District as being 2.588 mills Wiggins Rural Fire Protection District as being 7.000 mills

Commissioner Arndt made a motion to approve the local improvements and service districts mill levies as presented by Morgan County Information Services Director Karol Kopetzky, with Commissioner Westhoff seconding the motion. At this time, the motion carried 3-0.

The following Water Districts were summarized as being:

Morgan County Quality Water District as being 0.824 mills Prairie View Ranch Water District, LLC as being 0.000 mills

The following Water Conservancy Districts were summarized as being:

Central Colorado Water Conservancy as being 1.068 mills

Central Colorado Water Conservancy - Groundwater Management Subdistrict as being 1.582 mills

Lower South Platte Water Conservancy District as being 1.000 mills

Northern Colorado Water Conservancy as being 1.000 mills

Well Augmentation Subdistrict of Central Colorado Water Conservancy District as being 9.000 mills

Commissioner Westhoff made a motion to approve the Morgan County Quality Water District, Prairie View Ranch Water District, Central Colorado Water Conservancy, Central Colorado Water Conservancy - Groundwater Management Subdistrict, Northern Colorado Water Conservancy and Well Augmentation Subdistrict of Central Colorado Water Conservancy District mill levies as presented by Morgan County Information Services Director Karol Kopetzky, with Commissioner Arndt seconding the motion, noting that the Lower South Platte Water Conservancy District is being left out. At this time, the motion carried 3-0.

Chairman Becker stated he would like to remove the Lower South Platte Water Conservancy District from the other districts with Commissioner Westhoff in agreeance. Chairman Becker believes that the Lower South Platte Water Conservancy District should not be certified due to a belief that it should be put to a vote of the people, not seemingly being legislated from within the court system. He reiterated his strong support for the agricultural community.

Commissioner Westhoff stated that he is unsure whether to move forward or not being as it is currently within the appeals process in the courts.

Commissioner Arndt stated that he believes that it's not the commissioner's job to decide whether the mill levies are legal or illegal but simply to collect and submit the taxes from the levies.

Commissioner Westhoff made a motion to not approve the Lower South Platte Water Conservancy District mill levies as presented by Morgan County Information Services Director Karol Kopetzky, with Chairman Becker seconding the motion. At this time, the motion carried 2-1 with Commissioner Arndt being the dissenting vote.

Ms. Kopetzky further summarized the County Pest Control Districts indicating:

Fort Morgan Pest Control District as being 0.299 Wiggins Community Pest Control District as being 0.451 mills

Commissioner Westhoff made a motion to approve the County Pest Control districts mill levies as presented by Morgan County Information Services Director Karol Kopetzky, with Commissioner Arndt seconding the motion. At this time, the motion carried 3-0.

That the 2022 appropriation for the Morgan County Ambulance Fund is hereby increased from \$1,675,936 to \$1,725,936.

He also stated that his department is concerned with the current state of valuation versus the public perception of the valuation. He plans to communicate with the commissioners on a more regular basis.
