WHEREAS, to comply with the statutory licensing requirements, the Morgan County Board of County Commissioners adopts the Morgan County Ambulance Regulations.

1. The attached Morgan County Ambulance Regulations are hereby adopted.

Morgan County Attorney, Kathryn Sellars presented to the Board for approval Resolution 2022 BCC 07, a Resolution Adopting Ambulance Licensing Regulations for Morgan County. Ms. Sellars stated the County has not previously adopted these; however pursuant to State law no one is permitted to operate an ambulance department or ambulance service without being licensed by the Board of County Commissioners. Ms. Sellars stated this does include the County's own ambulance services. Under this statue it also provides for a process for each ambulance to be inspected and permitted. Morgan County Finance Director Michelle Covelli explained that they received notice from Medicare, Medicaid and medical work compensation insurance for the State that they requested copies of the

license in order to pay the bill for services to be paid. Commissioner Westhoff asked how many have not been paid with Ms. Covelli stating that there has only been one.

Commissioner Arndt made the motion to approve Resolution 2022 BCC 07, a Resolution Adopting Ambulance Licensing Regulations for Morgan County as presented by Morgan County Attorney, Kathryn Sellars and Morgan County Finance Director, Michelle Covelli. Commissioner Westhoff seconded the motion and motion carried 3-0.

Consideration of Approval - Town of Log Lane Village Quitclaim Deed Reception # 790736

Morgan County Road Supervisor, John Goodman presented to the Board the Quit Claim Deed from Morgan County to Log Lane Village. Mr. Goodman read the deed into the record. Commissioner Arndt asked if this will give Log Lane Village the full maintenance of Cedar Street from Highway 144 north to that point, with Mr. Goodman stating he doesn't believe so it is only the east west section of north Cedar so the west half of Cedar Street will still be Morgan County's responsibility.

Commissioner Westhoff made the motion to approve the Quit Claim Deed for the Town of Log Lane Village. Commissioner Arndt seconded the motion and motion carried 3-0.

 - a. The application documents are complete and represent how the subdivision will be laid out including infrastructure, easements and access.
 - b. The subdivision is in conformance with the Morgan County Comprehensive Plan and there is access to established public infrastructure.
 - c. The subdivision is compatible with surrounding land uses.

Morgan County Planning and Zoning Assistant, Charlotte Bolduc presented to the Board for approval Resolution 2022 BCC 08, a Resolution Granting a Four-Lot Minor Subdivision, Known As The Greene Becker Minor Subdivision. Ms. Bolduc explained that on January 10, 2022, the Planning Commission held a public hearing on an application from Joshua H. Becker and Rhiannon R. Greene, for a 4-lot minor subdivision on their property located in the NE ¼, of the NW ¼ of Section 15, Township 4 North, Range 58 West of the 6th P.M. Morgan County, Colorado and commonly known as: 15360 and 15426 County Road W, Weldona, Colorado 80653. The Planning Commission recommended approval on a vote of 3 in favor, 2 opposed with two members absent. On February 1, 2022 the Board of County Commissioners considered the application and approved with a vote of 2 - 0. Resolution 2022 BCC 08 reflects the outcome of that hearing. Chairman Pro Tem Westhoff asked if there were there any changes to the resolution after it was approved, with Ms. Bolduc stating no there was not.

Commissioner Arndt made the motion to approve Resolution 2022 BCC 08, a Resolution Granting a Four-Lot Minor Subdivision, Known As The Greene Becker Minor Subdivision as presented by Morgan County Planning and Zoning Assistant, Charlotte Bolduc. Chairman Pro Tem Westhoff seconded the motion and motion carried 2-0.

Chairman Pro Tem Westhoff turned the meeting back to Chairman Becker.

UNFINISHED BUSINESS

There was no unfinished business.

COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS

Morgan County Clerk and Recorder Chief Deputy Clerk Randee Aleman provided an update regarding 2022 General Election.

Morgan County Emergency Director, Roger Doll stated that Morgan County will have a Weather Spotter Training that is free to public on March 15, 2022 at 6 P.M. at Morgan County College in the Bloedorn Lecture hall.

Mr. Doll explained that Morgan County has moved to Code Red for Morgan county citizen's to receive emergency alerts. He encouraged citizen to go to Morgan County's website and sign up to receive those alerts.

Commissioners went over the road report ending February 25, 2022.

PUBLIC HEARING

Chairman Becker called the hearing to order at 9:25 a.m. in the Assembly Room of the Morgan County Administration Building. Present were, Chairman Jon Becker, Commissioner Gordon Westhoff and Commissioner Mark Arndt, Morgan County Attorney Kathryn Sellars and Morgan County Planning and Zoning Assistant Charlotte Buldoc.

1.) Amendments to the Morgan County Zoning Regulations:

Related to home occupations in the Jackson Lake Village Zone District and home occupations in general.

Ms. Buldoc stated that the Planning Commission reviewed this amendment to the home occupation regulations at the meeting on February 14, 2022 and recommends approval on a vote of 7 in favor, 0 opposed.

Ms. Buldoc explained that to allow home occupations in the Jackson Lake Village Zone and to clarify the purpose of the home occupation regulations.

Section 1. Section 3-600 (E) of the Morgan County Zoning Regulations is amended by the addition of new subsection (5) to read as follows:

(5) Home occupations

Section 2. Section 4-305 of the Morgan County Zoning Regulations is amended to read as follows:

The purpose and intent of the home occupation regulations is to allow for certain home occupations within the County based on specific limits and requirements. These regulations are also intended to ensure that home occupations are compatible with the residential development in the surrounding neighborhoods and to protect the overall community character.

Section 3.

Section 4-310 of the Morgan County Zoning Regulation is amended to read as follows:

All home occupations in the County are subject to the following restrictions: See under Home Occupations in the Morgan County Zoning Regulations.

Ms. Sellars clarified that the regulations associated with home occupations remain unchanged, the limited retail sales and the outside storage nothing is changing, this is simply allowing home occupations within the Jackson Lake Village Zone, but not modifying restrictions on that use.

Chairman Becker if there was anyone in the audience present or online who wished to make public comment in opposition or in favor of the application, noting no public comment and closed the public comment portion at this time.

At this time, Chairman Becker moved into discussion and decision.

Commissioner Westhoff made a motion to approve the Resolution 2022 BCC 09 Amendments to the Morgan County Zoning Regulations: Related to home occupations in the Jackson Lake Village Zone District and home occupations in general, as presented by Morgan County Planning and Zoning Assistant Charlotte Buldoc. The motion was seconded by Commissioner Arndt. At this time, the motion carried 3-0.

Being no further business the meeting was then adjourned at 9:31 a.m.
