The Board of Morgan County Commissioners met Tuesday, March 15, 2022 at 9:10 a.m. with Chairman Jon Becker, Commissioner Gordon Westhoff and Commissioner Mark Arndt in attendance.

CITIZEN'S COMMENT

Alan Quiram, 215 East 6th Avenue, Fort Morgan, appeared remotely, and stated he had two questions for the Board today regarding the funds the County has been awarded through the American Rescue Plan (ARPA). His questions were if would be possible for the Commissioners to provide the details for the plan in improving the justice center and will all the 5.6 million dollars that have been awarded to Morgan County be used for one County project.

Chairman Becker stated the full final bids have not been received by the County and that the funding will all be used for what is called the Morgan County Justice Center project.

Leroy Chavez, PO Box 564, Fort Morgan, appeared remotely, and stated he basically has the same questions and asked if there are other projects being considered and further asked why there has not been an opportunity for public input regarding the expenditures of these funds. Chairman Becker responded stating the County has followed the guidelines set forth. The Board determined that these funds would be best utilized for the HVAC system at the Justice Center and have followed the criteria set forth. Mr. Chavez further commented he has been doing some research as he has special interest in this matter given his family has had COVID and from what he has read and understands, part of the requirements for these funds is that there should be the requirement for public input, and he has not seen this as an opportunity given by the County and that is his reason for his comments today. Chairman Becker stated that from what he had read, the County was not required to take public comment for these funds.

Jillian Degenhart, 511 Main Street, Weldona, CO, appearing remotely, also questioned about the public comment and why despite the urging of the treasury the Board has chosen not to allow for the public comment. Chairman Becker stated at this point they believed the Justice Center was the need for these funds and explained that this was allowable under the federal government guidelines.

Ms. Deganhart asked when and where the budget will be made publicly available for review. Chairman Becker stated the budgeting of these dollars was included in the approval of the last budget process, and the project will be open bid and available to the public.

Jodi Walker, spoke remotely, stating she realizes the jail is an important project, and asked the question for the Board if it is willing to sit down and listen to the survey results and have a meeting, and feels it is important for the board to hear from their constituents. Chairman Becker stated at this time, those dollars are designated to the Justice Center project. Ms. Walker questioned Chairman Becker if he was stating the board is not willing to listen to the citizens, with Chairman Becker providing a response explaining that he has listened to the several emails and concerns and that was not what he stated. Ms. Walker again stressed her concerns that there are issues surrounding mental health as well as housing and asked the board to listen to the surveys. Again, Chairman Becker provided a response regarding two committees that have been seated regarding both of those issues, with Commissioner Westhoff providing an update regarding those issues and the monies that may be awarded that could provide resources for these issues she has spoken about.

Chairman Becker stated they have invited at least the results of the survey to come through and they would look at this information and are hopeful that mental health dollars come through for the teen suicide issue as well.

Ms. Kopetzky spoke about a fairly lengthy chat that appears remotely, and she has opened the mic for them to speak. At this time, Olivia, organizer for United Today, Stronger Tomorrow, address being based out of Durango, 3935 County Road 250, Durango, CO. She stated she is here today to support the local citizens and what she has shared in the chat is information she has found in the Treasury bill.

Commissioner Arndt provided a clarification of the boundaries whereas the information was detailed by the use of the mapping to be sure that there is the precise historical information provided in the minutes. North portion of Cedar Street being the far north boundary and at this time, it is not annexed into the Town of Log Lane at which they will have to do an annexation at a later date, the right of way is for this entire area, the upper portion of the location is a 50/50 as a shared street and when annexations are completed, it will be in the best interest of the County to further investigate whether or not that should remain.

Commissioner Arndt further stated this matter today is to convey the far north portion of Cedar Street as part of this right of way deed and it will remain with the County until the Town completes their annexation.

A RESOLUTION AMENDING THE MORGAN COUNTY ZONING REGULATIONS TO ALLOW HOME OCCUPATIONS IN THE JACKSON LAKE VILLAGE ZONE AND TO CLARIFY THE PURPOSE OF THE HOME OCCUPATION REGULATIONS

WHEREAS, home occupations are currently not permitted in the Jackson Lake Village zone district;

WHEREAS, the County desires to permit home occupations as an accessory use in the Jackson Lake Village zone subject to the restrictions on home occupation in Secs. 4-305 through 4-315 of the Morgan County Zoning Regulations;

WHEREAS, on February 14, 2022, the Planning Commission held a duly noticed public hearing on the proposed amendments and recommended approval;

WHEREAS, on March 1, 2022, the Board of County Commissioners held a duly noticed public hearing on the proposed amendments;

WHEREAS, the Board of County Commissioners has complied with all relevant provisions for amending the Morgan County Zoning Regulations; and

WHEREAS, after considering public testimony received and the recommendation of the Planning Commission, the Board of County Commissioners finds these amendments to be in the best interest of the citizens of Morgan County.

NOW THEREFORE BE IT RESOLVED by the Morgan County Board of County Commissioners as follows:

Section 1. Section 3-600(E) of the Morgan County Zoning Regulations is amended by the addition of a new subsection (5) to read as follows:

(5) Home occupations

Section 2. Section 4-305 of the Morgan County Zoning Regulations is amended to read as follows:

The purpose and intent of the home occupation regulations is to allow for certain home occupations within the County based on specific limits and requirements. These regulations are also intended to ensure that home occupations are compatible with the residential development in the surrounding neighborhoods and to protect the overall community character.

Section 3. Section 4-310 of the Morgan County Zoning Regulations is amended to read as follows:

All home occupations in the County are subject to the following restrictions:

Ms. Aleman an application for a special events permit for Morgan Community College Foundation for the Morgan Community College Gala was received; such event is scheduled for Friday, April 22, 2022. The application being submitted on February 7, 2022, by Authorized Representative for the Organization, Madalyn Babcock, who has provided the necessary documentation and payment as required for a special events permit in Morgan County. Our office has provided a copy of the information to the Board. This matter has been properly posted and all legal requirements have been met which include that of the notice of hearing having been published in the Fort Morgan Times on February 11, 2022 as well as signage having been placed at the location of this event for the required time frame, commencing on February 22, 2022.

Ms. Babcok has provided documentation from the Morgan County REA, Rob Baranowski confirming the approval of the application filed by Morgan Community College Foundation for serving and/or selling liquor at the proposed location, Morgan County REA warehouse space, located 734 Barlow Road, Fort Morgan, Colorado. A diagram of the area in which alcohol will be sold and served has also been provided as required. This permit is being requested for the date Friday, April 22, 2022 and if approved will be valid for the period of time between 10:00 a.m. and 10:00 p.m.

A background check has been completed for Ms. Babcock, who is named as the Authorized Representative for the Organization and Roberta Bigalk named as the Event Manager of the organization of this event and no concerns have been reported. At this time, Ms. Susan Bailey, County Clerk, stated she spoke with Sheriff Dave Martin this morning who has indicated he has no issues or concerns with this application being approved.

At this time, Chairman Becker opened the matter for public comment with no comment.

A motion was made by Commissioner Westhoff to approve the Special Events Permit submitted by Roberta Bigalk representing Morgan County Community College on April 22, 2022 at the Morgan County REA warehouse located at 734 Barlow Road, Fort Morgan, Colorado as presented by Morgan County Chief Deputy Randee Aleman.
