The Board of Morgan County Commissioners met Tuesday, April 5, 2022 at 9:00 a.m. with Chairman Jon Becker, Commissioner Gordon Westhoff and Commissioner Mark Arndt in attendance. Chairman Becker asked Public Works Director Bruce Bass to lead the meeting in the Pledge of Allegiance.

#### **CITIZEN'S COMMENT**

Katie Roth, 623 Warner Street, Fort Morgan, asked questions regarding the jail tour that took place last week asking the Board for their thoughts of what they feel is the most pressing issue. Commissioner Arndt stated this tour occurs once a year which is a statutory requirement, further stating it used to be done monthly but given the change in law, it is now an annual requirement. He spoke about the issues being reviewed as being inmate capacity and water temperature as well as those requirements set forth by statute. He further provided comments regarding those matters that are of importance at the jail, speaking about critical staffing levels, COVID related issues as well as heating and cooling concerns.

Commissioner Westhoff also spoke about his findings of the facility expressing that the building is beginning to show its age and his concerns as well about the heating and cooling issues as well as the water temperatures.

Chairman Becker also spoke stating through COVID the board has learned a great deal and feels the safety issue for the officers is of utmost importance and feels those items need to be addressed explaining there have been studies completed and discussions and feels it is time to start working on those matters.

Commissioner Westhoff made a motion to approve items 1-22 as presented, Commissioner Arndt seconded the motion. At this time the motion carried 3-0.

#### GENERAL BUSINESS AND ADMINISTRATIVE ITEMS

#### Consideration of Approval – RFP 2022-0324-001 Chip Seal Aggregate

Morgan County Public Works Director, Bruce Bass presented to the Board RFP 2022-0324-001 Chip Seal Aggregate Bid Tabulation and Award Bid Tabulation and Award. Mr. Bass stated one bid was received from Albert Frei and Sons in the amount of \$30.25 per ton, totaling approximately \$242,000.00. Mr. Bass summarized previous freight costs providing numbers in comparison. Mr. Bass stated this vendor has provided materials to the County for several years and the County has not experienced any issues with this vendor in the past.

At this time, Mr. Bass recommended the bid be awarded to Albert Frei and Sons in the amount of \$242,000.00 stating this is for an estimated total.

At this time, Commissioner Arndt noted a correction to the agenda that this is RFP 2022-0324-001 being for Chip Seal Aggregate and not Emulsified Asphalt as presented in the posted agenda.

Commissioner Arndt made the motion to approve bid award RFP 2022-0324-001 Chip Seal Aggregate Bid Tabulation and Award in the amount of \$30.25 per ton, totaling approximately \$242,000.00 to Albert Frei and Sons, and as recommended by Morgan County Public Works Director, Bruce Bass, noting it was the only bid received. Commissioner Westhoff seconded the motion and motion carried 3-0.

#### Consideration of Approval - RFP 2022-0324-002 Small Wheeled Loader Bid Tabulation and Award

Morgan County Public Works Director, Bruce Bass presented to the Board RFP 2022-0324-002 Small Wheeled Loader Bid Tabulation and Award Bid Tabulation and Award. Mr. Bass stated this does replace equipment owned by the property at this time at which a trade in proposal was allowed. Mr. Bass stated that they received two bids one from Wagner Equipment Company in the amount of \$85,615.54 including the trade in and the second one is from Wagner Equipment Company in the amount of \$100,638.34 including the trade in. Mr. Bass stated there was an additional price sheet provided for the guarding package for both submitted bids.

At this time, Mr. Bass recommended based on these two returns, referencing the recommendation submitted by Cass Yearous, Manager of the Landfill, the recommendation would be to stay with the CAT 906M explaining the reasons and agreed with Mr. Yearous' proposal for the additional three guarding packages the bid be awarded to Wagner Equipment and Company in the amount of \$93,081.04.

Commissioner Westhoff asked questions regarding the weight issues, with J.R. Harsh with Wagner Equipment Company responding to the questions asked. Discussion followed with specific questions and responses with available information. Mr. Bass stated this machine is being used inside the building and explained what it is being used for.

Commissioner Arndt made comment regarding Mr. Bass as being the Fleet Coordinator and his knowledge of how these machines operate and feels it is necessary to take his recommendation as to what works best and would agree with his recommendation for the 906M feeling it is the most economical and prudent purchase. Mr. Bass stated Mr. Yearous also agrees that the 906M will work sufficiently and provided an overview of discussions he and Mr. Yearous have had regarding this matter.

Mr. Bass also stated that he did check as the trade in proposal being a fair value being given after looking at auction sites as to what this machine would bring and recommends purchasing the 906M accepting the trade in value of \$21,000 plus the three guards.

Commissioner Westhoff made the motion to approve bid award RFP 2022-0324-002 Small Wheeled Loader Bid Tabulation and Award in the amount of \$93,081.04 to Wagner Equipment Company, and as recommended by

Morgan County Public Works Director, Bruce Bass for the 906M with the additional guards and accepting the trade in value as proposed. Commissioner Arndt seconded the motion and motion carried 3-0.

#### **COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS**

#### Darlene Carpio – Legislative Update

Darlene Carpio, Regional Director for the Eastern Plains for Congressman Ken Buck, provided a Legislative Update to the Board.

Morgan County Ambulance Director Travis Freeman shared information regarding grant funded project he and staff have been working on through RETAC and explained AED's have been placed in several agencies across the County. He stated they also have a list of others that have been placed within the County so they are aware of those who have them onsite. He summarized the maintenance requirements and the CPR training that has been provided to those employees at these businesses so they are trained on how to utilize the AED machine. He also provided an update as to the number of calls for service as well as the shortage in staffing levels they are experiencing at this time. He asked the Board to provide assistance to he and his staff to be able to continue providing emergency medical services to the County, expressing his concerns about the salary that is being offered and the high numbers of resignations he has been experiencing. Discussion followed with Commissioner Arndt commending Director Freeman for his efforts and his working so hard in obtaining grant funding and the services they are providing.

Morgan County Human Resource Director Tracy Amen expressed concerns about staffing shortages the County departments are currently experiencing and provided comment as to the great benefit package the County provides and encouraged citizens to apply.

Commissioners reviewed the calendar dated April 1, 2022 through April 12, 2022 with no changes. Commissioner Westhoff stated that there will be a meeting for the Brush Rodeo Association on April 6<sup>th</sup> and invited anyone who may be interested.

Being no further business the meeting was then adjourned at 9:50 a.m.
