Re: Taelor Solar Project

As an organization, MCEDC supports economic development activity in Morgan County. The success of any business depends largely on a supportive community. Our work focuses on supporting primary employers; those that bring equity into the local economy by supporting the retail, service, and professional sectors.

We envision a region with a healthy and sustainable economy that creates wealth, preserves the quality of life, and improves the standard of living for area residents. When engaging with potential projects our personal opinions are set aside and we evaluate three primary factors: job creation, tax revenue, and community engagement and support efforts.

To the best of our knowledge, Taelor Solar is working toward all three. They have engaged with and become investors of MCEDC. In an attempt to be a good neighbor, Taelor Solar has remained steadfast in their community engagement efforts, prioritizing initiatives for economic development, regardless of varying perspectives and community reaction.

The estimated economic benefits that Taelor Solar could bring with their proposed project in Morgan County supports job creation and new tax revenue.

The breakdown of estimated property tax payments obtained for the Taelor Solar Project website is as follows:

- \$9.8 million to RE 50-J Wiggins General
- \$5.9 million to RE 50-J Wiggins Bond
- \$2.8 million to Wiggins Rural Fire District
- \$7.8 million to the County General Fund
- \$3 million to the Road and Bridge Fund
- \$800,000 to the Social Services Fund
- \$180,800 to Wiggins Pest Control
- \$9,200 to N Kiowa Bijou Management District



- Additional revenue of \$32.5 million forecasted to the RE 50-J Wiggins School District account, sourced from Weld County parcels

These figures represent financial support to vital sectors within our community. The diverse range of contributions, from bolstering emergency services to supporting infrastructure development. Additionally, the direct and indirect economic impact from the construction and ongoing operations of Taelor Solar is assumed.

MCEDC supports projects that contribute to the economic health of Morgan County and its residents. We want to demonstrate our support and encouragement for our communities and any project that promotes harmonious partnerships that enhance the quality of life for new and existing businesses. We serve as a resource partner and will participate in discussions and meetings to help bring community involvement and collaboration to Morgan County.




We appreciated the efforts of Taelor Solar since the planning and zoning hearing to address any potential impacts of concern to my property and other neighboring properties.
