Hello,

My recommendation for the compact loader is the 908M.

I believe that this is necessary because of the increase in tonnage that is being brought in by the high capacity trucks. I think the extra weight of the equipment is worth the extra cost.

As far as guards, I am recommending the following:

- 1. Lower Window Debris Guard Kit
- 2. RH Belly Guard Kit
- 3. Drive Line Guard Kit (908M)

We haven't had a lot of problems with the hoses so I don't see the reason to spend money on guards for them. As far as windows, the only windows we've had to replace more than once is the drivers door window but I don't know the cost of that so I can't say if the Cab Door Screen kits are worth it or not. I am not against installing the door screens if you feel they are worth it.
