RESOLUTION 2024 BCC 30

- **WHEREAS**, the County owns and controls County Road GG within the County of Morgan, Colorado;
- **WHEREAS**, the County has received a request from Luke-Sky, LLC, a property owner, whose property accessed from and located adjacent to County Road GG, to close a portion of County Road GG between County Road 10 and County Road 8;
- **WHEREAS**, the majority of County Road GG is not currently constructed between County Roads 8 and 10;
- **WHEREAS**, County Road GG is not used as access to any other property but Luke-Sky, LLC's property;
- **WHEREAS**, the closure is requested, because of possible illegal activity on this portion of County Road GG, including vandalism;
- **WHEREAS**, the Commissioners desire to close this portion of County Road GG as shown on Exhibit A, attached hereto;
- **WHEREAS**, this closure shall not be deemed to be an abandonment or a vacation of the closed portion of County Road GG and the County retains all rights to County GG, including the right to rescind this Resolution and open County Road GG to public access; and
- **WHEREAS**, Luke-Sky, LLC along with its invitees shall be provided access to the closed portion of the road as needed to access their property and may install a gate as provided for in this Resolution.

NOW THEREFORE BE IT RESOLVED BY THE MORGAN COUNTY BOARD OF COUNTY COMMISSIONERS AS FOLLOWS:

- <u>Section 1</u>. The portion of County Road GG shown on the attached Exhibit A is hereby ordered closed to public traffic; provided that the property owner, Luke-Sky, LLC, is authorized to access said property.
- <u>Section 2.</u> The property owner, Luke-Sky, LLC, is authorized to install a gate as in the location shown on Exhibit A; provided its exact location and design are approved in advance of its installation by Morgan County's Road Department; and provided further, that Morgan County is provided with a means to open the gate at will.
- **Section 3.** No buildings or structures may be installed or constructed within the closed right of way. The closure of the road will not modify or adjust the setback requirements

for any new buildings, structures or uses on the adjacent properties. Setbacks shall be measured from the road right of way.

<u>Section 4.</u> The Morgan County Boad of County Commissioners may reopen the closed portion of County Road GG at any time it determines it to be in the best interests of the County and its residents. If the roadway is reopened, the property owner shall remove the gate at its expense.

Section 5. Morgan County's Road Department is hereby directed to coordinate with the property owner to effectuate the closure.
