**A PROCLAMATION CHANGING THE NAME OF THE UNINCORPORATED TOWN

**WHEREAS**, in 1978, the miniseries Centennial was partially filmed in Morgan County and the unincorporated Town of Orchard was the location for the fictional town of Centennial; and

**WHEREAS**, the Board of County Commissioners desires to rename the unincorporated Town of Orchard to “Centennial” for one day, August 2, 2024, to honor and celebrate the filming of the miniseries.

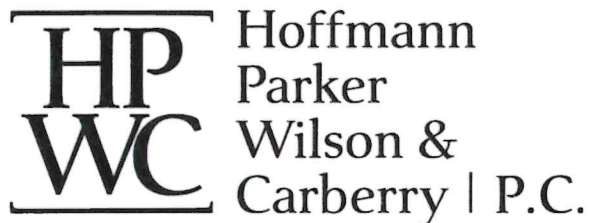

**Re: Waiver of Potential Conflict with Wiggins Rural Fire Protection District**

Dear Commissioners:

This letter addresses my firm's representation of both Morgan County and Wiggins Rural Fire Protection District ("WRFPD"). With this letter, we seek the County's informed consent to a limited waiver of a potential conflict.

Currently, we represent both Morgan County and WRFPD as general counsel. It is my understanding that both clients wish to work cooperatively to establish a mutual agreement related to emergency medical care. Because any mutual agreement would be between two of our clients, both the County and WRFPD must determine whether they find our firm's representation of their interests acceptable given our concurrent representation of both entities.

Please let me know if you have any questions. It is important that the County's consideration of this request be both informed and with the advice of independent counsel. Should the County elect to waive this conflict and consent to the arrangement with a limited waiver of this specific conflict of interest as described herein, I will need to have the Chair countersign this letter below.
