Consideration of Approval – Bid Tabulation and Award, RFP 2024-0418-001 Morgan County Asphalt Paving Projects

Morgan County Public Works Director, Bruce Bass, presented to the Board for approval, Bid Tabulation and Award, RFP 2024-0418-001 Morgan County Asphalt Paving Projects. Mr. Bass explained that he received two bids one from Holcum WCR, Inc. in the amount of \$1,905,227.00 and one from Martin Marietta Materials in the amount of \$1,450,405.75. Mr. Bass further summarized each bid in detail for the projects that were scheduled. He noted that with the recommended company that the project will come in under budget by \$247,595.
