The Board of Morgan County Commissioners met Tuesday, January 6<sup>th</sup>, 2026 at 9:02 a.m. Chairman Jon Becker, Commissioner Tim Malone and Commissioner Kelvin Bernhardt were in attendance. Chairman Becker asked Pete Wagner of KFTM to lead the meeting in the Pledge of Allegiance.

**CITIZENS COMMENT**

At this time, Commissioner Bernhardt made a motion to approve items 1-2 as presented; Commissioner Malone seconded the motion. The motion carried 3-0.

**GENERAL BUSINESS AND ADMINISTRATIVE ITEMS**

**Consideration of approval – Introduction and First Reading of Ordinance No. 1, Series 2026, An Ordinance Adopting the 2024 Model Traffic Code**

Morgan County Attorney, Kathryn Sellars explained that the County is currently operating under the 2003 Model Traffic Code. She noted that this change will make it so that certain violations may be enforced on private property, careless driving while backing was updated, and it also updated the compression brake restrictions which were updated last year by the board. She stated that this also updates penalties. It was noted that spilling on the roadway fines would now be \$250 with a court summons.

Chairman Becker thanked everyone who has worked on this ordinance.

Commissioner Malone made a motion to approve the Ordinance No.1, Series 2026, An Ordinance Adopting the 2024 Model Traffic Code as presented for the first reading; Commissioner Bernhardt seconded the motion. The motion carried 3-0.

**COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS**

Commissioners reviewed the calendar dated January 2, 2026 through January 13, 2026 with no changes.

Morgan County Clerk and Recorder, Kevin Strauch updated the commissioners on the Home Rule election and the amount of petitions that have been deemed sufficient. He noted that there are three candidates in District One, four candidates in District Two, three candidates in District Three, and two At-Large. He noted that these candidates would be posted on the departments Facebook page as soon as they were finalized.
