UNFINISHED BUSINESS

Bid Tabulation - RFP 2025-0102-001 Morgan County Fairgrounds Hog and Sheep Barn

Morgan County Building Maintenance, Mike Cox, presented to the Board for approval Bid Tabulation and Award RFP 2025-0102-001 Morgan County Fairgrounds Hog and Sheep Barn. Mr. Cox explained that this bid was first submitted to the previous Board and it was tabled until the new Board took office. Mr. Cox explained he received five bids, a bid from Chisel Construction in the amount of \$1,650,984.00, a bid from Buildings By Design in the amount of \$1,359,223.00, a bid from Eric Reichert Insulation & Construction, Inc. in the amount of \$1,481,836.00, a bid from Keefe construction Services in the amount of \$1,128,184.00 and a bid from Mesa Fab Shop, Inc. that was submitted incomplete. Mr. Cox further summarized the details of each bid submitted.

At this time, Mr. Cox recommended the bid be awarded to Keefe Construction, who was the lowest bidder in the amount of \$1.128.184.00.

Commissioner Malone asked for clarification if the price from Keefe Construction included a new lean-too. Mr. Cox said that it did.

Chairman Becker asked if this included removing the current hog and sheep barn. Mr. Cox said that it did.

Commissioner Malone made a motion to accept the Bid Tabulation and Award RFP 2025-0102-001 Morgan County Fairgrounds Hog and Sheep Barn to Keefe Construction in the amount of \$1,128,184.00, as recommended by Morgan County Building Maintenance, Mike Cox, with Commissioner Bernhardt seconding the motion. At this time motion carried 2-1 with Chairman Becker voting against.

Bid Tabulation - RFP 2024-1031-001 Facilities Infrastructure Replacement Project

Morgan County Building Maintenance, Mike Cox, presented to the Board for approval Bid Tabulation and Award RFP 2024-1031-001 Facilities Infrastructure Replacement Project. He stated that this is part of the DOLA project that is currently being work on. This part of the project is for solar. Mr. Cox explained he received one bid from Douglass Colony in the amount of \$160,000.00. Mr. Cox further summarized the details of the bid.

At this time, Mr. Cox recommended the bid be awarded to Douglass Colony, who was the only bidder in the amount of \$160,000.00.

Commissioner Malone asked if it was difficult to find contactors for this specific type of project. Mr. Cox answered that he was unsure.

Chairman Becker asked if the company was going to take care of any permits. Mr. Cox said they would. He also asked if this bid included battery backup as well. Mr. Cox stated that that it did not.

Commissioner Malone made a motion to accept the Bid Tabulation and Award RFP 2024-1031-001 Facilities Infrastructure Replacement Project to Douglass Colony in the amount of \$160,000.00, as recommended by Morgan County Building Maintenance, Mike Cox, with Commissioner Bernhardt seconding the motion. At this time motion carried 3-0.

Consideration of Approval – Letter of interest and Certificate of Appointment for Fair Board vacancy - Jordan Traxler, term ending December 31, 2025
