The Board of Morgan County Commissioners met on Tuesday, February 25, 2025 at 9:00 a.m. with Chairman Jon Becker, Commissioner Tim Malone, and Commissioner Kelvin Bernhardt in attendance. Chairman Becker asked Morgan County Human Services Accounting Manager, Susan Nitzel to lead the meeting in the Pledge of Allegiance.

At this time, the Board convened as the Morgan County Board of Social/Human Services. Chairman Becker noted that Jacque Frenier, Morgan County Department of Human Services Director, and Accounting Manager Susan Nitzel were present.

Consideration of Approval –DHS Minutes dated January 28, 2025

Chairman Becker presented for review and approval the Department of Human Services Minutes dated January 28, 2025. A motion was made by Commissioner Malone to approve the minutes as presented with Commissioner Bernhardt seconding the motion. The motion carried 3-0.

Consideration of Approval – DHS WARRANTS – December 2024

Susan Nitzel, Accounting Manager presented to the Board for their review and approval of the Department of Human Services Warrants for the month of December 2024. Ms. Nitzel summarized the operating warrants as being a total of \$348,853.99 for operating costs and direct deposits for payroll were \$216,798.83, which totaled \$565,652.82. Ms. Nitzel stated that compared to November there was a considerable amount more spent, which was in program grants and they were able to catch up to numerous payments.

Commissioner Bernhardt made the motion to approve the warrants as presented for December 2024 in the amount of \$565,652.82 as presented and authorized the Chairman to sign with Commissioner Malone seconding the motion. Motion carried 3-0.

Consideration of Approval – DHS CERTIFICATION OF PROVIDER AND VENDOR BENEFIT AUTHORIZATIONS – December 2024

Susan Nitzel, Accounting Manager presented to the Board for their review and approval the Department of Human Services Certification of Provider and Vendor Benefit Authorizations for December 2024. Ms. Nitzel summarized the Certification of Provider and Vendor Benefit Authorizations indicating the monthly total of \$895,763.89. Ms. Nitzel stated that there was a difference of \$10.00 from November to December. There was a decrease in LEAP and increase in OAP and the food stamps. Compared to December of last year there was a decrease of \$16,000, which was in child care and food stamps.

Chairman Becker asked if there has been any word on if any programs will be cut by the Federal Government, with Ms. Nitzel stating they have not heard anything as of yet.

Commissioner Malone made the motion to approve the Certification of Provider and Vendor Benefits as presented for December 2024 in the amount of \$895,763.89, as presented and authorized the Chairman to sign, with Commissioner Bernhardt seconding the motion. Motion carried 3-0.

Ms. Frenier stated that they still have openings in the child support department and in the front office. Also, the LEAP program is still open and citizens can apply online at PEAK for energy assistance.

There being no further business, the Board stood in recess at 9:07 a.m.

Consideration of Approval of Consent and Limited Waiver for HPWC concerning Wiggins Rural Fire Protection District

Kathryn Sellars, Morgan County Attorney, presented to the Board for approval Consent and Limited Waiver for HPWC concerning Wiggins Rural Fire Protection District 5. Ms. Sellars explained that they represent both Wiggins Rural Fire Protection District and the County. The parties have had agreements of storage of property and use of each other's facilities. The Wiggins Fire Chief and Ambulance Director Travis Freeman have been going through those agreements and some of those agreements have expired. This waiver will cover any drafting of those agreements, if the parties cannot agree each party would have to obtain separate council.

Commissioner Malone asked if both parties get together and work on getting an Intergovernmental Agreement in order, with Ms. Sellars stating that is correct. Ms. Sellars stated that this waiver has been done in the past.

Commissioner Malone asked if the building is owned by Wiggins Fire, with Ms. Sellars stating that was correct.

Commissioner Bernhardt stated that from his experience in the past the Wiggins Fire and the Morgan County Ambulance have a great working relationship. Chairman Becker mentioned it has been done in the past and it has worked well and he is confident in signing this waiver.

Commissioner Malone made a motion to approve and authorize the chair to sign the Approval of Consent and Limited Waiver for HPWC concerning Wiggins Rural Fire Protection District as presented by Kathryn Sellars, Morgan County Attorney with Commissioner Bernhardt seconding the motion. At this time, the motion carried 3-0.
