The Board of Morgan County Commissioners met on Tuesday, March 18, 2025 at 9:00 a.m. with Chairman Jon Becker, Commissioner Tim Malone, and Commissioner Kelvin Bernhardt in attendance. Chairman Becker asked Morgan County Human Services Accounting Manager, Susan Nitzel, to lead the meeting in the Pledge of Allegiance

At this time, the Board convened as the Morgan County Board of Social/Human Services. Chairman Becker noted that Jacque Frenier, Morgan County Department of Human Services Director, and Accounting Manager Susan Nitzel were present.

Consideration of Approval –DHS Minutes dated February 25, 2025

Chairman Becker presented for review and approval the Department of Human Services Minutes dated February 25, 2025. A motion was made by Commissioner Malone to approve the minutes as presented with Commissioner Bernhardt seconding the motion. The motion carried 3-0.

Consideration of Approval – DHS WARRANTS – January 2025

Susan Nitzel, Accounting Manager presented to the Board for their review and approval of the Department of Human Services Warrants for the month of January 2025. Ms. Nitzel summarized the operating warrants as being a total of \$333,179.44 for operating costs and direct deposits for payroll were \$225,853.21, which totaled \$559,032.65. Ms. Nitzel stated that from December to January was a decrease of around \$15,000. She noted that most of that was due to program costs with a decrease in grants and that the county interfund was not received.

Commissioner Bernhardt made the motion to approve the warrants as presented for January 2025 in the amount of \$559,032.65 as presented and authorized the Chairman to sign with Commissioner Malone seconding the motion. Motion carried 3-0.

Consideration of Approval – DHS CERTIFICATION OF PROVIDER AND VENDOR BENEFIT AUTHORIZATIONS – January 2025

Susan Nitzel, Accounting Manager presented to the Board for their review and approval the Department of Human Services Certification of Provider and Vendor Benefit Authorizations for January 2025. Ms. Nitzel summarized the Certification of Provider and Vendor Benefit Authorizations indicating the monthly total of \$895,203.76. Ms. Nitzel stated that from December to January, there was a decrease of approximately \$500. Compared to a year ago, she noted that there was an increase of \$9,700 with an increase in food stamps and a decrease in child care and core services.

Chairman Becker asked to clarify if the county had any power over food stamps and the school meal program. Ms. Nitzel noted that these were controlled by other governmental and school entities with no input from Morgan County. She noted that they are just charged with being an intermediary.

Commissioner Malone made the motion to approve the Certification of Provider and Vendor Benefits as presented for January 2025 in the amount of \$895,203.76, as presented and authorized the Chairman to sign, with Commissioner Bernhardt seconding the motion. Motion carried 3-0.

Morgan County Director of Human Services, Jacque Frenier noted that April is Child Abuse Prevention Awareness week. She noted that their office would be holding "spirit days" each day with different themes.

There being no further business, the Board stood in recess at 9:09 a.m.

 - c. The resultant lots will meet the required minimum lot size and lot width of the applicable zoning district. If any of the lots are nonconforming with respect to the minimum lot size or lot width, the reconfiguration must not increase the nonconformity.
 - d. The reconfiguration will not create a nonconforming setback for any existing building.
 - e. Except for those nonconformities addressed in subsection (c) above, the resultant lots will meet the requirements of the applicable zone district, including those requirements in Table 1 of Appendix B of the County's Zoning Regulations.
 - f. The reconfiguration will not adversely affect access, drainage or utility easement or rights-of-way serving the property or other properties. A shared access acknowledgment has been signed and recorded in the records of the Morgan County Clerk and Recorder for the shared driveway off of Highway 34.
 - g. The reconfiguration is consistent with the goals and policies of the County's Comprehensive Plan.
 - 2. The Board hereby approves the Myers Amended Plat, an amended plat of Lots 1, 2, and 3 of the Holzworth Minor Subdivision in the NE¼ of Section 3, Township 3 North, Range 58 West of the 6th P.M., Morgan County, Colorado.

1. APPROVAL.

The Board hereby approves the rezoning of the parcel of land located in the SW¼ of Section 31, Township 4 North, Range 55 West of the 6th P.M., Morgan County, Colorado, otherwise known as 29870 U.S. Highway 6, Brush, CO 80723 from Agricultural/Agri Business (A/B) to Commercial (C). The property description is more particularly described as Parcel A in Warranty Deed recorded at reception number 949493 in the records of the Morgan County Clerk and Recorder:

- 3. The Board, having reviewed the Application and all information provided finds that:
 - The rezoning is consistent with the provisions of the Morgan County Comprehensive Plan. Specifically:
 - Diversify the economy in Morgan County to broaden business employment opportunities for residents and to further economic growth. Rezoning the historic property will allow for diverse land use opportunities for the community.
 - The rezoning is compatible with surrounding zone districts. The parcel to the north is zoned Commercial, parcel to the east and south is zoned Agricultural Production, the parcels to the west is zoned Light Industrial, and Agricultural/Agri Business. With this mix of surrounding zoning, Commercial zoning is compatible.
 - The rezoning is in the best interests of the citizens of Morgan County and in addition, furthers the health, safety, or general welfare of the citizens of Morgan County. Conditions in the area of the proposed rezoning or in adjacent areas have changed or are changing to such a degree as to warrant the rezoning. The area is moving away from a focus on Agricultural/Agri Business uses and into an area diverse with commercial and industrial uses.

MORGAN COUNTY, COLORADO RESOLUTION 2025 BCC 15

A JOINT RESOLUTION OF THE MORGAN COUNTY BOARD OF COUNTY COMMISSIONERS AND THE MORGAN COUNTY SHERIFF OPPOSING SENATE BILL 25-003

WHEREAS, Senate Bill 25-003, which, if passed, will regulate the manufacture, distribution, transfer, sale, and purchase of specified semi-automatic firearms and classify a rapid-fire device as a prohibited dangerous weapon:

WHEREAS, the Second Amendment to the United States Constitution, adopted in 1791 as part of the Bill of Rights, protects the inalienable and individual right of the people to keep and bear arms;

WHEREAS, the Supreme Court in the *District of Columbia v. Heller*, 554 U.S. 570 (2008), held that "[t]he Second Amendment...is the very product of an interest balancing by the people...(which) surely elevates above all other interests the rights of law-abiding, responsible citizens to use arms in defense of hearth and home...";

WHEREAS, the Supreme Court in *McDonald v. Chicago*, 561 U.S. 742 (2010), affirmed that the right of an individual to "keep and bear arms," as protected under the Second Amendment, is incorporated by the Due Process Clause of the Fourteenth Amendment against the "infringement by the States";

WHEREAS, the Supreme Court, in *United States v. Miller*, 307 U.S. 174 (1939), opined that firearms that could "contribute to the common defense" are protected by the Second Amendment;

WHEREAS, Article II, Section 3 of the Constitution of Colorado provides that all "persons have certain inalienable rights, among which may be reckoned the right of enjoying and defending their lives and liberties; of acquiring, possessing and protecting property; and of seeking and obtaining their safety and happiness...";

WHEREAS, Article II, Section 13 of the Constitution of Colorado provides that the "right of no person to keep and bear arms in defense of his home, person and property, or in aid of the civil power when thereto legally summoned, shall be called in question...";

WHEREAS, Article II, Section 11 of the Constitution of Colorado provides that no "ex post facto law, nor law impairing the obligation of contracts, or retrospective in its operation...shall be passed by the general assembly...";

WHEREAS, Senate Bill 25-003 will impose unconstitutional, harsher, unnecessary, and ineffective restrictions on law-abiding citizens and result in an unconstitutional overreach by the Colorado General Assembly;

WHEREAS, Senate Bill 25-003 imposes another unfunded mandate on Counties to manage the licensing process for semi-automatic firearms, resulting in increased costs for personnel, record-keeping, and regulatory oversight;

WHEREAS, many Counties are currently struggling to provide essential services and infrastructure to their citizens and Senate Bill 25-003 will divert even more funding away from these services;

WHEREAS, Senate Bill 25-003 will also have a detrimental impact on firearm-related businesses, including manufacturers, retailers, and sporting organizations that contribute to local economies and could result in job losses, decreased tax revenue, and harm to small businesses;

WHEREAS, the Board of County Commissioners and the Morgan County Sheriff took an oath to support and defend the United States Constitution, the Constitution of the State of Colorado and the laws of the State of Colorado and by implication, question the constitutionality of legislation that infringes upon constitutional rights, while supporting practical and effective public safety measures;

WHEREAS, Senate Bill 25-003 does not represent practical and effective public safety measures and imposes excessive and unnecessary burdens on responsible and law-abiding gun owners, counties, and law enforcement agencies; and

WHEREAS, Senate Bill 25-003 disregards the values of the citizens of Morgan County, will negatively impact them financially, and will infringe upon and harm their quality of life.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MORGAN COUNTY, COLORADO:

Section 1. The Morgan County Board of County Commissioners and the Morgan County Sheriff strongly oppose Senate Bill 25-003 and urge Governor Polis to veto this legislation and consider alternative approaches that respect constitutional rights while effectively addressing public safety concerns.
