A PROCLAMATION CHANGING THE NAME OF THE UNINCORPORATED TOWN OF ORCHARD TO CENTENNIAL FOR AUGUST 2, 2024 IN HONOR OF THE FILMING OF THE MINISERIES CENTENNIAL

WHEREAS, in 1978, the miniseries Centennial was partially filmed in Morgan County and the unincorporated Town of Orchard was the location for the fictional town of Centennial; and

WHEREAS, the Board of County Commissioners desires to rename the unincorporated Town of Orchard to "Centennial" for one day, August 2, 2024, to honor and celebrate the filming of the miniseries.

NOW THEREFORE, BE IT PROCLAIMED BY THE BOARD OF COUNTY COMMISSIONERS OF MORGAN COUNTY, COLORADO:

<u>Section 1.</u> The unincorporated Town of Orchard, Morgan County, Colorado is renamed to "Centennial" for one day, August 2, 2024.

At this time, Commissioner Westhoff made a motion to adopt the Proclamation 2024 BCC 33 Changing the Name of the Unincorporated Town of Orchard to Centennial for August 2, 2024 In Honor of the Filming of the Miniseries Centennial, as presented with Commissioner Becker seconding the motion. The motion carried 3-0.

2 COMMISSIONERS PROCEEDINGS

Consideration of approval of waiver for Hoffmann, Parker, Wilson & Carberry, P.C.

Commissioner Becker explained this waiver is for our attorney who also represents Wiggins Rural Fire Protection District can act on both parties' halves to come to a common agreement to allow Wiggins Rural Fire Protection District to provide some medical services at the scene when they respond to accidents and how the hand off of care is done. The policy will be worked on by the Wiggins Rural Fire Protection District Chief and Morgan County Ambulance Director Travis Freeman.

Chairman Arndt stated this is a standard waiver when the same attorney represents both parties.

At this time, Commissioner Becker made a motion to approve the waiver for Hoffmann, Parker, Wilson & Carberry, P.C., to represent Morgan County and Wiggins Rural Fire Protection District, with Commissioner Westhoff seconding the motion. The motion carried 3-0.

Consideration of approval of Revised Public Safety Salary Structure.

Chairman Arndt stated that this needs to be acted upon since when the salary structure was approved in January 2024 and was revised July 24, 2024 for the Public Safety Salary Structure which is on page 6 of the structure, grade 5 communications technicians moving the minimum from \$3,906 to \$4,412.

Commissioner Westhoff stated that this is an additional \$506 a month, with Chairman Arndt stating that is correct. Chairman Arndt explained that the salary survey will be looking at all the structures there will possibly not be numerous categories there will be one salary structure.

At this time, Commissioner Westhoff made a motion to approve the Revised Public Safety Salary Structure, as presented with Commissioner Becker seconding the motion. The motion carried 3-0.
