Commissioner Westhoff made a motion to approve Resolution 2024 BCC 32 a Resolution approving stop signs to be installed at the intersection of County Roads L and 6, Morgan County, Colorado. Commissioner Becker seconded the motion and motion carried 3-0.

Approval of Waiver of RFP Process and Approval of Contract 2024 CNT 093 with Moetivations, Inc. for training and additional personnel for the Morgan County Communication Center

Commissioner Becker presented to the Board for Waiver of RFP Process and Approval of Contract 2024 CNT 093 with Moetivations, Inc. for training and additional personnel for the Morgan County Communication Center. He noted this was due to a "perfect storm" of retirements and other happenings in the department. The company could provide up to eight employees that could be trained quickly and used from up to five to eight months.

Commissioner Westhoff noted that the RFP process was waived as help is needed immediately and that the process would take four to eight weeks otherwise.

Chairman Arndt noted that there is a contract in place with Moetivations, Inc currently for other purposes.

Commissioner Becker made a motion to approve the Waiver of RFP Process and Approval of Contract 2024 CNT 093 with Moetivations, Inc. for training and additional personnel for the Morgan County Communication Center, with Commissioner Westhoff seconding the motion. At this time motion carried 3-0.

Commissioner Becker thanked the Communications Center employees for staying with the county and working hard despite the issues.

Consideration of Approval – Bid Tabulation and Award, RFP 2024-0711-001 Morgan County Rotary Cutter

Morgan County Public Works Director, Bruce Bass, presented to the Board for approval Bid Tabulation and Award RFP 2024-0711-001 Morgan County Rotary Cutter. Mr. Bass explained he received five bids, a bid from Hall Manufacturing LLC in the amount of \$22,844.85, a bid from One Nation Distribution LLC in the amount of \$24,998.00, a bid from TAZA Supplies Inc. in the amount of \$45,999.00, a bid from 21st Century Equipment LLC in the amount of \$20,600.00 and a bid from Wiggins Electric Inc. in the amount of \$23,445.00. Mr. Bass noted that this is a budgeted item.

At this time, Mr. Bass recommended the bid be awarded to 21^{st} Century Equipment, who was the lowest bidder in the amount of \$20,600.00.

Commissioner Westhoff made a motion to accept the Bid Tabulation and Award RFP 2024-0711-001 Morgan County Rotary Cutter to 21st Century Equipment LLC in the amount of \$20,600.00, as recommended by Morgan County Public Works Director, Bruce Bass, with Commissioner Becker seconding the motion. At this time motion carried 3-0.

Consideration of Approval – Bid Tabulation and Award, RFP 2024-0711-002 Morgan County AWD Motor Grader

Morgan County Public Works Director, Bruce Bass, presented to the Board for approval Bid Tabulation and Award RFP 2024-0711-002 Morgan County AWD Motor Grader. Mr. Bass explained he received two bids, a bid from Wagner Equipment Company in the amount of \$478,762.00 and a bid from 4 Rivers Equipment LLC in the amount of \$605,100.00. Mr. Bass further summarized the details of each bid submitted. He noted that this is an approved budget item. He also noted that these include a seven-year rotation which includes a machine buy back or trade for the current machines.

At this time, Mr. Bass recommended the bid be awarded to Wagner Equipment Company, who was the lowest bidder in the amount of \$478,762.00.

Commissioner Becker made a motion to accept the Bid Tabulation and Award RFP 2024-0711-002 Morgan County AWD Motor Grader to Wagner Equipment Company in the amount of \$478,762.00 after trade ins, as recommended by Morgan County Public Works Director, Bruce Bass, with Commissioner Westhoff seconding the motion. At this time motion carried 3-0.

Consideration of Approval – Bid Tabulation and Award, RFP 2024-0711-003 Morgan County Conventional Truck Tractor

Morgan County Public Works Director, Bruce Bass, presented to the Board for approval Bid Tabulation and Award RFP 2024-0711-003 Morgan County Conventional Truck Tractor. Mr. Bass explained he received three bids, a bid from Bruckner's Truck & Equipment in the amount of \$167,898.00, a bid from McCandless Truck Center LLC in the amount of \$174,839.35 and a bid from Transwest Truck trailer RV in the amount of \$165,711.00. Mr. Bass further summarized the details of each bid submitted.

At this time, Mr. Bass recommended the bid be awarded to Transwest Truck Trailer RV, who was the lowest bidder in the amount of \$165,711.00.

Commissioner Westhoff made a motion to accept the Bid Tabulation and Award RFP 2024-0711-003 Morgan County Conventional Truck Tractor to Transwest Truck Trailer RV in the amount of \$165,711.00, as recommended by Morgan County Public Works Director, Bruce Bass, with Commissioner Becker seconding the motion. PUBLIC HEARING

Chairman Mark Arndt called the hearing to order at 10:13 a.m. on Tuesday, August 6th, 2024 in the Assembly Room of the Morgan County Administration Building.

Chairman Mark Arndt, Commissioner Jon Becker, and Commissioner Gordon Westhoff were present. Planning and Zoning Administrator Nicole Hay, Planning and Zoning Technician Jenafer Santos, Building Inspector Troy Black and IT Specialist Karol Kopetzky were also present.

REGULATION AMENDMENTS OVERVIEW:

Planning Administrator Nicole Hay read her file summary as follows:

AMENDMENTS MORGAN COUNTY ZONING REGULATIONS

The State has recently adopted rules regarding tiny homes and tiny houses. The County has seen increased inquiries into whether it allows these types of residences and the Morgan County Building Department has requested that amendments be made to the County's Zoning Regulations to clarify whether these residences would be allowed. Staff recommends allowing these residences within the current structure of uses in each zone district. Included with this staff report are redlines of the proposed changes as outlined below.

Planning Commission held a work session on these amendments on June 10, 2024 and made recommended revisions to the initial draft. Those revisions are highlighted

The Planning Commission recommended approval at a public hearing held on July 8, 2024 on a vote of 6 in favor and 0 opposed.

Overview of proposed changes:

- 1. <u>Definitions</u>. Addition of definitions for loft, tiny home and tiny house. Revision of Recreational Vehicle to include tiny homes.
- 2. <u>Tiny Home</u>. The proposed amendments will add requirements related to tiny homes. If the owners want to place the tiny home or put it on a permanent foundation, it will be subject to the same permitting as a manufactured home that is placed or is on a permanent foundation. If the tiny home remains on its wheels, it will be treated as a recreational vehicle. Colorado tiny homes will receive a metal plate insignia installed under the sink by the State Division of Housing. When placed or on a permanent foundation, the tiny home will also receive a metal plate installation insignia.
- 3. <u>Tiny House</u>. The proposed amendments will add requirements related to tiny houses. By definition, these dwellings are under 400 square feet, are constructed on a permanent foundation and will require a building permit meeting or exceeding the current adopted building code.

Also included in your packets is a Department of Local Affairs FAQ, excerpts from Archuleta County and La Plata County Regulations and photo examples.

BOARD OF COUNTY COMMISSIONER DISCUSSION:

Troy Black noted that if someone brings one of these types of homes in and wants to purge it, it is up to the Assessor's office to either allow it or not.

Commissioner Becker asked what year of tiny home is allowed?

Troy Black stated that they have to go through the process through DOLA. They have to be a state approved structure. If it's an older structure they will have to get it approved by going through inspections with the state to get the insignia. He is unaware of a specific date.

Commissioner Becker asked how we handle the offices that are converted into homes? How do these definitions cover those?

Troy Black said it has to go through the DOLA program. It can still be approved as a registered RV, but it has to be approved to be a livable structure. They will either have to take the homes to them or have an inspector come out to the home to be able to get that insignia.

Commissioner Westhoff asked if they are going to get a certificate or something similar to show it's been inspected properly?

Troy Black answered that it is going to be ran very similarly to how HUD is doing it with manufactured homes.

Commissioner Becker asked if that inspection is possible for us to do it here.

Troy Black said that they do have training programs if we wanted to do it. There were only 4-6 homes that have been put through so far. He believes it's best to keep it as it is to get inspected through the state. **Commissioner Becker** asked if we are having a lot of requests for tiny homes?

Troy Black, "We were having a lot for a little bit. I was having 4-5 calls a week at one time."

Commissioner Westhoff asked if it's still on wheels, will it not be taxed until it's tied to a foundation? **Director Tim Amen** stated that they are both still taxed, whether it's on wheels or not.

Commissioner Westhoff motioned to approve the amendments for the Morgan County Zoning Regulations for tiny homes and tiny houses as described.

Commissioner Becker seconded. Motion carries 3-0.

Being no further business the meeting was adjourned at 10:30 a.m.
